19	BE IT ENACTED BY THE	GENERAL ASSEMBLY OF THE STATE OF ARKAN	ISAS:

21	SECTION 1. The	Director of the Department of Finance	and Administratio
22	shall provide for and	issue special Wild Turkey Federation	motor vehicle
23	license plates in the	manner and subject to the conditions	prescribed herein.
24			
25	SECTION 2. The	special Wild Turkey Federation licens	se plates shall be
26	designed by the Arkan	sas State Chapter of the Wild Turkey F	ederation and shal
27	be submitted for the	approval of the Director of the Depart	ment of Finance an
28	Administration. Upon	approval of the design by the Departm	nent of Finance and
29	Administration and th	e deposit with the department of fifte	en hundred dollars
30	(\$1500) by the Arkans	as State Chapter of the Wild Turkey Fe	ederation, to cover
31	the special license plate fee of ten dollars (\$10.00) for each of the first		
32	one hundred fifty (150) Wild Turkey Federation plates, the department shall		
33	cause to be prepared	one hundred fifty (150) motor vehicle	license plates of
34	the approved design. The first one hundred fifty (150) plates so prepared		
35	shall be numbered con	secutively beginning with the number C	<u>)01.</u>

1	SECTION 3. (a) The first one hundred fifty (150) special Wild Turkey		
2	Federation license plates shall be reserved by the department and such plates		
3	shall be issued to a vehicle owner only when the Arkansas State Chapter of the		
4	Wild Turkey Federation has certified that the person is eligible for one of		
5	the numbered Wild Turkey Federation plates and has specified the number of the		
6	plate to be issued to the person.		
7	(b) When a vehicle owner obtains a certificate from the Arkansas State		
8	Chapter of the Wild Turkey Federation, certifying that the owner is eligible		
9	to receive one of the first one hundred fifty (150) numbered special Wild		
10	Turkey Federation motor vehicle license plates and specifying the number of		
11	the plate which he or she is eligible to receive, the vehicle owner shall be		
12	entitled to receive the plate upon presentation of the certificate to the		
13	Office of Motor Vehicle and payment of the appropriate fees prescribed by law.		
14			
15	SECTION 4. (a) A motor vehicle owner applying for a special Wild		
16	Turkey Federation motor vehicle license plate under this act and who is		
17	authorized or certified by the Arkansas State Chapter of the Wild Turkey		
18	Federation as eligible to receive the plate but is not certified for one of		
19	the first one hundred fifty (150) numbered plates may:		
20	(1) Request a special Wild Turkey Federation license plate number		
21	assigned by the department as authorized herein; or		
22	(2) Apply for a special personalized Wild Turkey Federation		
23	prestige license plate pursuant to Arkansas Code § 27-14-1101 and § 27-14-		
24	1102.		
25	(b) The use of letters and numbers on a personalized prestige license		
26	plate, however, shall be limited by the rules and regulations of the Director		
27	of the Department of Finance and Administration.

29	SECTION 5. Any motor vehicle owner may apply annually to the Arkansas		
30	State Chapter of the Wild Turkey Federation, for use of the Wild Turkey		
31	Federation design on a license plate. Upon annual application and payment to		
32	the Arkansas State Chapter of the Wild Turkey Federation of a twenty-five		
33	dollar (\$25.00) design use contribution, the Arkansas State Chapter of the		
34	Wild Turkey Federation shall issue to the vehicle owner a "Design Use		
35	Authorization Statement", which shall be presented by the vehicle owner to the		
36	Department of Finance and Administration at the time of registration of a		

vehicle. Upon presentation of the annual Design Use Authorization Statement, 1 2 payment of the fee required by law for registration of the vehicle, and 3 payment of an additional ten dollar (\$10.00) handling and administrative fee for the special Wild Turkey Federation license plate, the Department of 4 5 Finance and Administration shall issue a Wild Turkey Federation license plate which shall bear the approved design to the vehicle owner. The handling and 6 7 administrative fee of ten dollars (\$10.00) shall be deposited to the State Central Services Fund for the benefit of the Revenue Division and shall be 8 9 credited to the Revenue Division as supplemental and in addition to all other 10 funds as may be deposited for the benefit of the Revenue Division. The handling and administrative fee shall not be considered or credited to the 11 12 Revenue Division as "direct revenues". 13 Special Wild Turkey Federation license plates issued under 14 SECTION 6. 15 this act may be renewed annually in accordance with the procedures set out in 16 Section 5 either in person or by mail, or by facsimile pursuant to Arkansas 17 Code § 27-14-1012 and § 27-14-1013. Registration may continue from year to 18 year as long as it is renewed each year within the time and manner required by 19 law. The design use contribution shall continue to be paid to the Arkansas 20 State Chapter of the Wild Turkey Federation separately from the payment due the Department of Finance and Administration. A motor vehicle owner who was 21 22 previously issued a license plate with the Wild Turkey Federation design 23 authorized by this act and who does not provide a Design Use Authorization 24 Statement at the subsequent time of registration shall be issued a new plate which does not bear the Wild Turkey Federation design. Upon expiration, the 25 26 special Wild Turkey Federation license plate may be replaced with a 27 conventional license plate, a personalized license plate, or a new special 28 Wild Turkey Federation license plate. 29 30 SECTION 7. Special Wild Turkey Federation license plates issued under 31 this act may be transferred from one vehicle to another pursuant to Arkansas 32 Code § 27-14-914. 33 SECTION 8. The Arkansas State Chapter of the Wild Turkey Federation 34 35 shall have no recourse against the Department of Finance and Administration if 36 any special Wild Turkey Federation license plate is erroneously issued or

1	renewed without payment of the Design Use Authorization Statement.	
2		
3	SECTION 9. The special Wild Turkey Federation license plates shall	
4	comply with all other state motor vehicle laws relating to registration and	
5	licensing of motor vehicles except as herein specifically provided.	
6		
7	SECTION 10. The Director of the Department of Finance and	
8	Administration shall promulgate such reasonable rules and regulations and	
9	prescribe such forms as he determines to be necessary for effectively and	
10	efficiently carrying out the intent and purposes of this act.	
11		
12	SECTION 11. All provisions of this act of a general and permanent	
13	nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas	
14	Code Revision Commission shall incorporate the same in the Code.	
15		
16	SECTION 12. If any provision of this act or the application thereof to	
17	any person or circumstance is held invalid, such invalidity shall not affect	
18	other provisions or applications of the act which can be given effect without	
19	the invalid provision or application, and to this end the provisions of this	
20	act are declared to be severable.	
21		
22	SECTION 13. All laws and parts of laws in conflict with this act are	
23	hereby repealed.
