The Treasurer of State shall first make monthly allocations on the 8 (a) 9 basis of 48.691% of the total available funds to the Executive Discretionary Division as set out in subsection (c); and 51.309% of the total available 10 11 funds to the Legislative Division listed in subsection (b) until all projects 12 enumerated in subsection (b) have been fully funded. The Legislative Division 13 funds shall be used to provide funds to each project enumerated in this 14 section in proportion that each project's allocation bears to the total of the 15 allocations of all projects enumerated in subsection (b). The remaining 16 available funds, after fully funding the Legislative Division projects, shall be made available for the Governor's Discretionary Division projects 17 18 enumerated in subsection (c). Funds made available to the Executive 19 Discretionary Division may be used for any project or portion thereof 20 enumerated within the Executive Discretionary Division but not to exceed the amount set out in subsection (c) for the project. The Chief Fiscal Officer of 21 22 the State shall notify the Legislative Council of the Governor's released 23 funds for projects at the same time that the Department of Finance and 24 Administration is notified.

3 SECTION 4. DISBURSEMENT OF FUNDS. Expenditure of the funds authorized by the Eighty-second General Assembly from the 82nd Session Projects Account 4 shall be made only upon documentation to the Chief Fiscal Officer of the 5 State, in such form as deemed necessary, that all criteria or pre-conditions 6 7 established in the appropriation act have been met or in the case of state agencies, and that a Method of Finance has been filed with the Office of 8 9 Accounting in the Department of Finance and Administration, if required. Anv matching funds as may be provided in law shall be certified to the Chief 10 11 Fiscal Officer of the State prior to the commencement of the project. 12 Further, any recipient of the funds appropriated herein may be required to 13 file a compliance audit indicating that the use of the funds was in compliance 14 with the intent of the General Assembly.

15

16 SECTION 5. TRANSFERS AUTHORIZED. In lieu of the project description 17 set out for NorthWest Arkansas Community College and Pulaski Technical College 18 in subsection (c) of Section 3 herein, the Governor may allow such funds, not 19 to exceed \$500,000 for either institution, as approved by the Governor to be 20 used for supplementing the operations of the institutions by transferring the 21 funds to the institutions' State Treasury fund.

22

23 SECTION 6. Any enactment of the 82nd General Assembly appropriating or 24 allocating funds to be payable from the "General Improvement Fund", for which 25 a specific allocation of funds is specifically authorized in this Act, shall be deemed to be payable from the "82nd Session Projects Account" within the 26 27 "General Improvement Fund" unless a specific intent is otherwise provided by 28 law. Any enactment of the 82nd General Assembly appropriating funds payable 29 from the General Improvement Fund which is not enumerated in this Act shall not be financed from monies accruing to the 82nd Session Projects Account. 30 31 Provided that monies reappropriated by the 82nd General Assembly for projects for which appropriations were made by the 81st General Assembly, which are not 32 33 enumerated in this Act and which are made payable from the "General 34 Improvement Fund", shall be payable from the "81st Session Projects Account" 35 of the "General Improvement Fund" and allowances shall be made therefore in arriving at the uncommitted and unobligated balance of monies in the "General 36

Improvement Fund" before making transfers therefrom to the "82nd Session
 Projects Account", as authorized by this Act.

4 SECTION 7. Distribution of funds for constructing and equipping the 5 radiation therapy institutes specified herein, shall be contingent upon the 6 provision of matching funds, including those monies previously raised but not 7 previously used to match state funds, on a dollar by dollar basis on behalf of 8 each such radiation therapy institute.

9

10 SECTION 8. All provisions of this act of a general and permanent nature 11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 12 Revision Commission shall incorporate the same in the Code.

13

SECTION 9. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

20 SECTION *10.* All laws and parts of laws in conflict with this act are 21 hereby repealed.

22

SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined that 23 24 Eighty-Second General Assembly meeting in Regular Session has considered and 25 enacted appropriations for construction projects and other programs to be 26 financed from the accumulated surplus and reserve funds available in the State 27 Treasury; that the total of the enacted appropriations exceed the estimated 28 available funds and that the immediate passage of this Act is necessary to 29 establish a method of providing for the orderly financing and a system of 30 priority for the financing of such projects. Therefore, an emergency is 31 declared to exist and this act being immediately necessary for the 32 preservation of the public peace, health and safety shall become effective on the date of its approval by the Governor. If the bill is neither approved nor 33 vetoed by the Governor, it shall become effective on the expiration of the 34 35 period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is overridden, it shall become effective 36
