23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code 25-16-904 is amended to read as follows:

26 "25-16-904. Stipend - Authorization for \$75.

27 Each of the following state boards may, by a majority vote of the total
28 membership of the board cast during its first regularly scheduled meeting of
29 each calendar year, authorize payment to its members of a stipend not to
30 exceed seventy-five dollars (\$75.00) per meeting attended, and the board
31 members shall receive no other compensation, expense reimbursement, or in-
32 lieu-of payments except as provided in § 25-16-902:

- 33 (1) Auctioneers Licensing Board;
- 34 (2) Arkansas Economic Development Commission;
- 35 (3) State Commission on Child Support;
- 36 (4) Supervisory Board for the Arkansas Crime Information Center;

- 1 (5) Board of Correction and Community Punishment;
- 2 (6) State Board of Education;
- 3 (7) Board of Embalmers and Funeral Directors;
- 4 (8) State Board of Health;
- 5 (9) Arkansas Health Policy Council;
- 6 (10) State Board of Optometry;
- 7 (11) Parks, Recreation, and Travel Commission;
- 8 (12) Arkansas State Board of Pharmacy;
- 9 (13) Arkansas Pollution Control and Ecology Commission;
- 10 (14) Post Prison Transfer Board;
- 11 (15) Arkansas Racing Commission;
- 12 (16) Arkansas Sentencing Commission; and
- 13 (17) State Board of Vocational Education.
- 14 (18) Oil and Gas Commission.
- 15 (19) Professional Bail Bond Company and Professional Bail
- 16 Bondsman Licensing Board;
- 17 (20) Arkansas Soil and Water Conservation Commission;
- 18 (21) Red River Commission."

20 SECTION 2. Arkansas Code 17-19-106 is amended to read as follows:

21 "17-19-106 is amended to read as follows:

22 (a) This section may be cited as the "Arkansas Professional Bail Bond
23 Company and Professional Bail Bondsman Licensing Act".

24 (b) There is hereby created the Professional Bail Bond Company and
25 Professional Bail Bondsman Licensing Board.

26 (1)(A) The board shall be composed of seven (7) members to be
27 appointed by the Governor for terms of seven (7) years.

28 (B) Vacancies shall be filled by appointment of the
29 Governor for the unexpired portion of the term.

30 (2)(A) Three (3) members of the board shall be licensed bail bond
31 company owners, one (1) a municipal chief of police, one (1) a county sheriff,
32 one (1) a municipal or circuit judge, and one (1) shall be a resident of the
33 state who is not a bail bond company owner, elected judge, sheriff, or chief
34 of police.

35 (B) No two (2) of the three (3) bail bondsman members shall
36 reside in the same congressional district, and at least one (1) of the bail

1 bondsman members shall be an African-American.

2 (3) The board shall have the authority and responsibility to
3 administer and enforce the provisions of this chapter relating to licensing
4 and regulation of professional bail bond companies and professional bail
5 bondsmen.

6 (4) The board shall have the authority to adopt and enforce such
7 reasonable rules and regulations as it shall determine to be necessary to
8 enable it to effectively and efficiently carry out its official duty of
9 licensing and regulating professional bail bond companies and professional
10 bail bondsmen.

11 (c) The members of the board shall ~~serve without compensation but may~~
12 receive expense reimbursement in accordance with § 25-16-901 et seq., and a
13 stipend pursuant to § 25-16-904.

14 (d) The provisions of this section shall not be construed to repeal any
15 laws in effect on August 13, 1993, relating to the licensing and regulation of
16 professional bail bond companies and professional bail bondsmen but such laws
17 shall remain in full force and effect and shall be administered by the board
18 created herein."

20 SECTION 3. Arkansas Code 25-16-903(49) and (55), establishing stipends
21 of fifty dollars (\$50.00) per day, are repealed.

23 ~~(55) Arkansas Soil and Water Conservation Commission;~~

25 SECTION 4. All provisions of this act of a general and permanent nature
26 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
27 Revision Commission shall incorporate the same in the Code.

29 SECTION 5. If any provision of this act or the application thereof to
30 any person or circumstance is held invalid, such invalidity shall not affect
31 other provisions or applications of the act which can be given effect without
32 the invalid provision or application, and to this end the provisions of this
33 act are declared to be severable.

35 SECTION 6. All laws and parts of laws in conflict with this act are
36 hereby repealed.
