## For An Act To Be Entitled

10 "AN ACT TO PROVIDE THAT IF A LAW IS NOT ENACTED IN  
11 THIS REGULAR SESSION TO PROVIDE FOR THE ELECTION OF  
12 THE SIX (6) TEMPORARY APPOINTEES TO THE COURT OF  
13 APPEALS THAT THEIR TERMS SHALL EXPIRE ON *JANUARY 1,*  
14 *2000* OR THE EFFECTIVE DATE OF THIS ACT, WHICEVER IS  
15 LATER; AND THE MEMBERSHIP OF THE COURT OF APPEALS WILL  
16 REVERT TO THE ORIGINAL SIX (6) MEMBERS; AND FOR OTHER  
17 PURPOSES. "

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. If the General Assembly does not enact law during this  
27 regular session to provide for the election of the six (6) additional  
28 positions on the Court of Appeals created by Act 1085 of 1993, as amended,  
29 those positions will become null and void on *January 1, 2000* if the regular  
30 session adjourns on or before April 1, 1999 or as of the effective date of  
31 this act if the General Assembly adjourns after April 1, 1999.

33 SECTION 2. All provisions of this act of a general and permanent nature  
34 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
35 Revision Commission shall incorporate the same in the Code.
