Arkansas Code Annotated 9-12-320 is hereby amended to read as follows: 25 26 "9-12-320. Proceedings subsequent to decree - change of venue. (a) The court where the final decree of divorce is rendered shall retain 27 28 jurisdiction for all matters following the entry of the decree. In divorce 29 proceedings, when a complaint for divorce is filed in a chancery court of one (1) chancery district and the final decree is rendered by the court and, If 30 more than six (6) months subsequent to the final decree, however, both of the 31 parties to the divorce proceedings have established a residence in a county of 32 another chancery district within the state, one or both of the parties may 33 petition the court which granted the final decree to request that the case be 34 35 transferred to another county. The case shall not be transferred absent a showing that the best interest of the parties justifies the transfer. In 36

- cases where children are involved and a justification for transfer of the case
 has been made, there shall be an initial presumption for transfer of the case
 to the county of residence of the custodial parent. further action upon such
 case may be brought in the county of residence of the custodial parent or

 rendered shall retain jurisdiction for a minimum of six (6) months following
 entry of that decree.
 - (b) At the request of the party seeking If the court which granted the final decree agrees to transfer the case to another chancery district, the court shall enter an order transferring the case and charging the chancery clerk of the court of original jurisdiction to transmit forthwith certified copies of all records pertaining to the case.
 - (c) Subsequent to the transfer to a county in another chancery
 district, if the party residing in the county to which the case has been
 transferred removes from that county or from the State of Arkansas, the case
 shall be transferred back to the county of original jurisdiction or the county
 of residence of the party still residing in the State of Arkansas.
 - $\frac{(c)}{(d)}$ The provisions of this section shall not repeal any laws or parts of laws in effect on March 3, 1975, relating to venue for divorce actions, but shall be supplemental thereto."

SECTION 2. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-second General Assembly that present law does not address the
