EMERGENCY CLAUSE. It is hereby found and determined by the 11 SECTION 6. 12 Eighty-second General Assembly that the duties of combined office of sheriff-13 tax collector in Izard County, Arkansas have become too burdensome for one (1) person to continue to perform effectively, that the combined responsibilities 14 15 of both offices in Izard County have grown beyond the supervisory capacity of one (1) person to continue to perform, and that it is necessary for this 16 combined office to be divided by law into two (2) separate offices with 17 18 exclusive responsibilities for different functions. Therefore, an emergency is declared to exist and this act being immediately necessary for the 19 20 preservation of the public peace, health and safety shall become effective on the date of its approval by the Governor. If the bill is neither approved nor 21 22 vetoed by the Governor, it shall become effective on the expiration of the period of time during which the Governor may veto the bill.
