For An Act To Be Entitled

10 "AN ACT TO ENHANCE SEISMIC MONITORING OF EARTHQUAKE
11 ACTIVITY IN ARKANSAS; AND FOR OTHER PURPOSES."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. It is hereby found and determined by the General Assembly
21 that earthquake activity in Arkansas has never been closely monitored by a
22 local network of seismic stations and that the realistic assessment of seismic
23 hazards in this state can only be accomplished by long term local monitoring
24 of earthquake activity in this state. Although the monitoring systems
25 operated by St. Louis University and the Center for Earthquake Research and
26 Information at the University of Memphis have provided a great deal of
27 information for risk assessment in the New Madrid seismic zone, the need for
28 monitoring within Arkansas has become apparent. It would be most beneficial
29 to the residents of this state for a collaborative program to be established
30 between St. Louis University, the University of Memphis, and the Arkansas
31 Center for Earthquake Education and Technology Transfer at the University of
32 Arkansas at Little Rock, in order to coordinate efforts and prevent
33 duplication. The Arkansas Center for Earthquake Education and Technology
34 Transfer is ideally located to handle the logistics of installing and
35 maintaining a network of seismic monitoring stations within this state and is
36 committed to offering the necessary personnel and facilities to efficiently

1 handle the undertaking. We must focus on establishing long-term, continuous
2 monitoring of earthquake activity in Arkansas in order to provide reliable
3 data for a realistic seismic hazard assessment and it is the intent of this
4 act to accomplish that purpose.

5
6 SECTION 2. The University of Arkansas at Little Rock is hereby directed
7 to establish the Arkansas Seismological Observatory as a part of the Arkansas
8 Center for Earthquake Education and Technology Transfer. The Arkansas
9 Seismological Observatory shall:

- 10 (1) Monitor earthquake activity throughout the state;
11 (2) Assist in emergency planning and in providing early warning;
12 (3) Provide public education regarding earthquake hazards;
13 (4) Provide information useful for earthquake hazard mitigation;
14 (5) Provide the scientific community with relevant data;
15 (6) Provide real time, immediate data regarding seismic activity to
16 government agencies such as the Office of Emergency Services, the Arkansas
17 Geological Commission, and critical facilities that operate in the region such
18 as Arkansas Nuclear One, the National Center for Toxicological Research, and
19 the Army Nerve Gas Facility; and
20 (7) Establish a collaborative relationship with St. Louis University
21 and the University of Memphis in order to coordinate efforts and prevent
22 duplication of effort.

23
24 SECTION 3. The seismic network operated by the Arkansas Seismological
25 Observatory should initially consist of at least ten (10) stations installed
26 at remote locations with the central recording station located on the campus
27 of the University of Arkansas at Little Rock. The complete monitoring network
28 should be established over a five (5) year period to allow for technological
29 upgrades so that state-of-the-art seismological equipment will be utilized
30 appropriately throughout the network.

31
32 SECTION 4. All provisions of this Act of a general and permanent nature
33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
34 Revision Commission shall incorporate the same in the Code.

35
36 SECTION 5. If any provision of this Act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
2 other provisions or applications of the Act which can be given effect without
3 the invalid provision or application, and to this end the provisions of this
4 Act are declared to be severable.

5

6 SECTION 6. All laws and parts of laws in conflict with this Act are
7 hereby repealed.
