### Subtitle

14 "UNI FORM CLASSIFICATION AND COMPENSATION  
15 ACT AMENDMENTS TO ESTABLISH THE TITLES  
16 AND GRADES FOR STATE AGENCIES. "

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code §21-05-203(11) is amended to read as follows:

23 "(11) ~~"Step"~~ "Pay Level" means any single rate of pay in a grade including  
24 the entrance, intermediate rates, and the maximum rate of pay; "

26 SECTION 2. Arkansas Code §21-5-208 is amended to read as follows:

27 "(a) There are established for state agencies and institutions of higher  
28 education covered by the provisions of this subchapter the following  
29 classification titles and grades. No payment of salaries may be made except in  
30 conformity with the maximum annual salary rates assigned to these grades for  
31 each year of the fiscal biennium as provided in the appropriation act of the  
32 agency or the institution and in this subchapter.

33 (b) The following classification titles with grades indicated are  
34 approved for the state classification plan, subject to the appropriation acts  
35 for the various state agencies and various institutions of higher education  
36 affected by this subchapter:

24 (a) The Office of Personnel Management shall have administrative

27 (b) Subject to funds and appropriations being provided, the following  
28 implementation procedures shall apply to state agencies and institutions

31 (1) The maximum annual salary rate for which an employee covered  
32 by the provisions of this subchapter shall be eligible for each year of the  
33 biennium shall be determined as follows:

34 The maximum rate of compensation for which an employee shall be eligible on  
35 July 1, ~~1997~~ 1999, shall be determined by increasing the employee's June 30,  
36 ~~1997~~1999, salary by two and eight-tenths percent (2.8%). Employees whose

1 salaries fall below Pay Level I for the grade assigned to their classification  
2 may be adjusted to the entry level. All other employees shall be adjusted to  
3 the appropriate pay level for the grade assigned to their classification but  
4 may not exceed the maximum rate provided for that grade unless otherwise

6 (2) Salary adjustments provided for in this section shall be made for all  
7 employees covered by the provisions of this subchapter prior to all other

10 The maximum rate of compensation for which an employee shall be eligible on

31 employee shall be eligible for an additional six percent (6%) increase in the  
32 new classification. An employee, upon reclassification, who is receiving a  
33 rate of pay that is less than the entrance rate for the new grade, may be  
34 adjusted to the new entrance rate.

35 (C) When an employee's position has been approved for  
36 reclassification to a classification title of a lower salary grade, the

1 employee's pay shall be fixed at a rate in the lower grade which does not  
 2 exceed the employee's rate of pay in the higher graded position at the time of  
 3 reclassification;

4 (c)(1) In the event that the Chief Fiscal Officer of the State  
 5 determines that general revenue funds are insufficient to implement the salary  
 6 increases authorized in this subchapter or any other law which affects salary  
 7 increases for state employees, the Chief Fiscal Officer may, upon approval of  
 8 the Governor, reduce the percentage of all authorized salary increases for all  
 9 state employees covered by this subchapter without regard to whether the  
 10 employees are compensated from general or special revenues, federal funds, or  
 11 trust funds.

12 (2) Provided that, if sufficient general revenues should then  
 13 become available at any time during the biennium to provide the maximum  
 14 additional salary increases for all state employees without regard to the  
 15 source of revenues, salary increases for state employees provided for in this  
 16 subchapter or any other law may then be fully implemented by the Chief Fiscal  
 17 Officer.

18 (d) All percentage calculations stipulated in this subchapter or any  
 19 other law affecting salaries of state employees may be rounded to the nearest  
 20 even dollar amount by the Office of Personnel Management when making the  
 21 percentage changes to state employee salaries."

 23 SECTION 4. Arkansas Code §21-5-219 is amended to read as follows:

24 " 21-5-219. Nonclassified employees.

6 SECTION 5 . NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED  
7 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GOVERNOR'S MANSION  
8 ADMINISTRATOR. The classified position of EXECUTIVE ADMINISTRATOR-GOVERNOR'S  
9 MANSION (041Z) is authorized for the Governor's Mansion for the 1999-2001  
10 biennium in lieu of the unclassified position of GOV OFC MANSION ADMINISTRATOR  
11 (7095). Except for the purpose of determining the maximum annual salary rate,  
12 which is applicable to the classification of 041Z, Executive Administrator-  
13 Governor's Mansion, this position shall be exempt from other provisions of  
14 the Uniform Classification and Compensation Act, or its successor, but shall  
15 not be exempt from the provisions of the Regular Salaries Procedures and  
16 Restrictions Act, or its successor.

17  
18 SECTION 6. There is hereby authorized for the Office of Attorney  
19 General the following additional positions which shall be supplemental and in  
20 addition to those positions authorized in Act 300 of 1999:

30 SECTION 7. All provisions of this act of a general and permanent nature  
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
32 Revision Commission shall incorporate the same in the Code.

34 SECTION 8. If any provision of this act or the application thereof to  
35 any person or circumstance is held invalid, such invalidity shall not affect  
36 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this  
2 act are declared to be severable.

3  
4 SECTION 9. All laws and parts of laws in conflict with this act are  
5 hereby repealed.

6  
7 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the  
8 Eighty-second General Assembly that that the Constitution of the State of  
9 Arkansas requires the General Assembly to set the titles and pay of state  
10 employees and that changes to titles and salaries must coincide with the  
11 beginning of the fiscal year. Therefore, an emergency is declared to exist  
12 and this act being immediately necessary for the preservation of the public  
13 peace, health and safety shall become effective on July 1, 1999.
