## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTI ON 1. Arkansas Code 7-5-409(b) is amended to read as follows:
"(b) If the applicant is regi stered or is otherwise eligi ble to vote absentee, the county clerk shall del iver or mail to the applicant or del iver pursuant to subsections (d) through (f) of this section to the person who del ivers the appl ication to the of fice of the county clerk pursuant to § 7-5403 the foll owing materials:
(1) An official ballot for each el ection named in the appl i cation;
(2) A seal able envel ope on whi ch there shall be no i dentifying marks;
(3) A seal able envel ope upon whi ch shall be printed or written $t$ he address of $t$ he county cl erk, precinct of voter and $t$ he wor ds: 'ABSENTEE BALLOT, .......... 19 ....., ELECTI ON’;
(4) A bl ank statement in the following form

I F YOU PROVI DE FALSE I NFORMATI ON ON THIS FORM YOU MAY BE GUI LTY OF PERJ URY

AND SUBJ ECT TO A FINE OF UP TO \$10, 000 OR I MPRI SONMENT FOR UP TO 10 YEARS.

SECTI ON 3. All provisions of this act of a general and permanent nature are amendat ory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revisi on Commissi on shall incorporate the same in the Code.

SECTI ON 4. If any provisi on of this act or the application ther eof to any person or circumstance is hel d invalid, such inval idity shal not affect ot her provisions or applications of the act which can be gi ven effect wi thout the i nval id provision or application, and to this end the provisions of this act are decl ared to be severable.

SECTI ON 5. All I aws and parts of laws in conflict with this act are hereby repeal ed.
