- SECTION 4. A motor vehicle owner applying for a special Ducks Unlimited motor vehicle license plate under this act and who is authorized or certified by Ducks Unlimited as eligible to receive such plate but is not certified for one of the first one hundred fifty (150) numbered plates may:
- (1) request a special Ducks Unlimited license plate number assigned by the department as authorized herein; or
- (2) apply for a special personalized Ducks Unlimited prestige license plate pursuant to Arkansas Code § 27-14-1101 and § 27-14-1102.

The use of letters and numbers on a personalized prestige license plate, however, shall be limited by the rules and regulations of the Director of the Department of Finance and Administration.

SECTION 5. Any motor vehicle owner may apply annually to Ducks

Unlimited, Inc., for use of the Ducks Unlimited design on a license plate.

Upon annual application and payment to Ducks Unlimited of a twenty-five dollar

- 1 (\$25.00) design use contribution, Ducks Unlimited shall issue to the vehicle
- 2 <u>owner a "Design Use Authorization Statement", which shall be presented by the</u>
- 3 <u>vehicle owner to the Department of Finance and Administration at the time of</u>

SECTION 9. The special Ducks Unlimited License plates shall comply with

all other state motor vehicle laws relating to registration and Licensing of

motor vehicles except as herein specifically provided.

SECTION 10. The Director of the Department of Finance and Administration shall promulgate such reasonable rules and regulations and prescribe such forms as he determines to be necessary for effectively and efficiently carrying out the intent and purposes of this act.

SECTION 11. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 12. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 13. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 14. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-second General Assembly that under the provisions of this act, the Office of Motor Vehicle has the responsibility to design or approve the design of special motor vehicle license plates and to adopt appropriate procedures for persons to apply for and qualify to receive such plates; that it is in the best interest of the Office of Motor Vehicle as well as the public that the office have the authority to proceed at once to make the necessary preparations for the issuance of the special license plates; and that it is essential that this act be given effect immediately to enable the Office of Motor Vehicle to do so. Therefore, an emergency is declared to exist and this

1	act being immediately necessary for the preservation of the public peace,
2	health and safety shall become effective on the date of its approval by the
3	Governor. If the bill is neither approved nor vetoed by the Governor, it
4	shall become effective on the expiration of the period of time during which
5	the Governor may veto the bill. If the bill is vetoed by the Governor and the
6	veto is overridden, it shall become effective on the date the last house
7	overri des the veto.
