SECTION 3. LEGISLATIVE INTENT. 25 SECTION 5. SEVERABILITY. If any provision of this act or the application 26 thereof to any person or circumstance is held invalid, such invalidity shall 27 not affect other provisions or applications of the act which can be given 28 effect without the invalid provision or application, and to this end the 29 provisions of this act are declared to be severable.

31 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict with 32 this act are hereby repealed.

1	the effectiveness of this Act on July 1, 1999 is essential to the operation of
