SECTION 14. SPECIAL LANGUAGE. STUDENT FINANCIAL AID - ANTI-STACKING. No postsecondary institution shall use public funds in a student aid package which exceeds the recognized cost of attendance at the institution where the student enrolls. Public funds are defined to include Arkansas Department of Higher Education (ADHE) scholarships and grants, state general revenues, tuition, or local tax revenue. All postsecondary institutions shall report to ADHE the total amount of financial aid from all sources for any student who receives an award from an ADHE program. When a student receives a total aid package that includes public funds and exceeds the cost of attendance, the institution shall repay public funds in the amount exceeding total cost of attendance. Such funds repaid shall be credited to the Higher Education Grants

SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER PROVISION. Upon certification by the Director of the Department of Higher Education that transfers are needed to make maximum utilization of funds and appropriations provided for financial aid programs, and with the approval of the Chief Fiscal Officer of the State and a review by the Arkansas Legislative Council, funds and appropriations may be transferred between financial aid programs, except that funds and appropriations may not be transferred for such purposes from either the Governor's Scholars Program or the Academic Challenge Scholarships Program in excess of \$1,000,000 in the aggregate in either fiscal year.

SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HIGHER EDUCATION PROMOTIONAL GRANTS. Upon certification by the Chairman Director of the State Board Arkansas Department of Higher Education to the Chief Fiscal Officer of the State, funds and appropriation provided to the Department of Higher Education for Higher Education Promotional Grants shall be transferred each fiscal year to each institution of higher education which received such funds in Fiscal Year 1995-96, in the proportion of the amount each institution received to the total amount which was distributed in Fiscal Year 1995-96 applied to the total amount of funds available each year, there to be used for the same purposes.

SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LOANS. In order to provide timely payments under financial aid appropriations made in this Act, the Chief Fiscal Officer of the State is authorized to provide loans from the Budget Stabilization Trust Fund to make available all funds attributable to the financial aid programs under the then current official revenue estimates. In the event of an unanticipated state revenue shortfall, any such loans remaining at the end of a fiscal year shall be repaid from revenues distributed in the first two months of the next fiscal year. Funds for appropriations made in this Act for purposes other than financial aid shall not be affected by the application of this provision.

SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORK FORCE 2000 DEVELOPMENT FUND PROCEDURES. After the amounts to be made available to the various technical colleges have been determined by the State Board of Higher Education under the provisions of Act 1244 of 1991 and Act 1246 of 1991, and upon the review and approval of the Chief Fiscal Officer of the State as set out in Arkansas Code 26-51-205(d)(2), such documents as may be necessary shall be processed so that funds may be transferred from the Work Force 2000 Development Fund to the State Treasury fund or fund account from which the technical college draws its general revenue support. Be it further provided that such Such funds as may be transferred shall not exceed 74.45% of the total funds available from the Work Force 2000 Development Fund during each fiscal year of the biennial period ending June 30, 1999 2001.

In the event that an educational institution a technical institute or comprehensive lifelong learning center which receives support from the Work Force 2000 Development Fund as determined by law or the State Board of Vocational Education transfers or merges into the Arkansas Technical College and Community College System for which Work Force 2000 Development Fund monies are determined by law, or the State Board of Higher Education, or vice versa then the actual amount of support from the Work Force 2000 Development Fund in the preceding fiscal year for such educational institution shall be made available irregardless irrespective of any other provision of law which sets out maximum levels of support from such fund.

SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUILDING MAINTENANCE FUND. After the sum of \$13,200,000 has been deposited into the Higher Education Building Maintenance Fund, the next \$10,000,000 or so much as is collected, is to be transferred to the Research Development Fund there to be used as provided by law.

SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO EXPENDITURES. Proceeds derived from the repayment of loans as authorized in Item (03) of Section 6 of this Act for the Math/Science Teacher Loan Awards

1 Program shall be deposited into the State Treasury as "Refunds to 2 Expenditures."

SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. The balance of the funds and appropriations as provided in Section 6 of this Act for the Governor's Scholars Program and the Academic Challenge Scholarships Program which remain on June 30, 1998 2000, shall be carried forward and made available for the same purpose for the fiscal year ending June 30, 1999 2001.

 SECTION 22. SPECIAL LANGUAGE. <u>NATIONAL GUARD TUITION ASSISTANCE PROGRAM. In addition to any other provisions of law, any student who receives assistance from the appropriation made for the "National Guard Tuition Assistance Program" in this Act shall repay any loans and/or assistance if the student does not receive an Honorable Discharge.</u>

SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GOVERNOR'S SCHOLARS PROGRAM. Should the funding of Governor's Scholars Program exceed the funding level of the <u>previous</u> fiscal year <u>ending June 30, 1997</u>, and the number of scholarships awarded increases to 200 or more <u>as a result of the actions of the Eighty First General Assembly</u>, the Department of Higher Education shall make every effort to assure a geographic distribution of the awards without compromising the academic criteria established for such awards.

SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HIGHER EDUCATION FORMULA DEVELOPMENT. The Department of Higher Education will work with the state college and university president's council to review, revise and develop funding formulae which will, in principle, seek to provide fair and equitable state support to all postsecondary students across the state, regardless of the state institution attended, while at the same time recognizing (a) the different needs for lower level, upper level, and graduate level instruction at the various institutions, (b) the requirements for specialized equipment and labs and smaller class sizes in some disciplines and

- 1 (c) unique missions, such as agricultural extension services, research,
- 2 medical sciences, workforce development, and public service; and (d) growth,
- 3 economies of scale and other appropriate factors. The formula will be
- 4 developed in consensus with the state college and university president's
- 5 council and presented to the State Higher Education Coordinating Board and the
- 6 Joint Budget Committee of the General Assembly for review.

- 8 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TUITION
- 10 ADJUSTMENT FUND. (a) HIGHER EDUCATION TUITION ADJUSTMENT FUND. The Higher
- 11 Education Tuition Adjustment Fund is hereby created upon the books of the
- 12 State Treasurer, State Auditor, and Chief Fiscal Officer of the State. The
- 13 fund shall consist of such revenues as are allocated to it by law.
- 14 (b) PURPOSE OF THE FUND. It is the intent of the Arkansas General Assembly
- 15 that this fund ensures that bonafide Arkansas income taxpayers and their
- 16 dependents who are residents of a bordering state in a contiguous county to
- 17 the Arkansas State line which is contiguous to a county where an insitution of

(c) APPROPRIATION TRANSFER PROCEDURES. The Director of the Arkansas

Department of Higher Education shall determine the difference between the 1 2 amount of tuition revenue which would have been generated by charging the 3 State Board of Higher Education approved out-of-state tuition rate to said 4 students as compared to approved in-state or out-of-district rate. Upon such determination, the Director of the Arkansas Department of Higher Education 5 shall certify to the Chief Fiscal Officer of the State and the State Treasurer 6 7 such amounts as are required to be transferred from the Higher Education 8 Tuition Adjustment Fund. SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOVING EXPENSES. Arkansas Code 19-4-522 is amended by inserting an additional subsection at the end thereof to read as follows:

State shall transfer to the Higher Education Tuition Adjustment Fund from the

Higher Education Grants Fund Account \$250,000 for each year of the biennium.

"(e) Notwithstanding Arkansas Code 19-4-522 or any other law to the contrary state-supported colleges and universities may utilize maintenance and operation appropriations for the payment of moving expenses of employees, including new hires."

SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OUT-OF-STATE TUITION WAIVER. The Board of Trustees of any institution of higher education may waive the out-of-state portion of any full tuition scholarship for any full-time student which is provided by unrestricted funds of the institution. Such part as is waived shall not be considered as an expenditure by any regulation of the Board of Arkansas Higher Education Coordinating Board.

SECTION 32. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER

OF HIGHER EDUCATION GRANTS FUND APPROPRIATIONS - HEALTH EDUCATION GRANTS.  SECTION 39. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 40. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 41. CODE. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 42. SEVERABILITY. If any provision of this act or the application

1	thereof to any person or circumstance is held invalid, such invalidity shall
2	not affect other provisions or applications of the act which can be given
3	effect without the invalid provision or application, and to this end the
4	provisions of this act are declared to be severable.

6	SECTION 43. GENERAL REPEALER. All laws and parts of laws in conflict with
7	this act are hereby repealed.

9	SECTION 44. EMERGENCY CLAUSE. It is hereby found and determined by the
10	Eighty-second General Assembly, that the Constitution of the State of Arkansas
11	prohibits the appropriation of funds for more than a two (2) year period; that
12	the effectiveness of this Act on July 1, 1999 is essential to the operation of
13	the agency for which the appropriations in this Act are provided, and that in
14	the event of an extension of the Regular Session, the delay in the effective
15	date of this Act beyond July 1, 1999 could work irreparable harm upon the
16	proper administration and provision of essential governmental programs.
17	Therefore, an emergency is hereby declared to exist and this Act being
18	necessary for the immediate preservation of the public peace, health and
19	safety shall be in full force and effect from and after July 1, 1999.
