20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby established for the Department of Higher Education - General Operations for the 1999-2001 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its successor.

SECTION 14. SPECIAL LANGUAGE. STUDENT FINANCIAL AID - ANTI-STACKING. No postsecondary institution shall use public funds in a student aid package which exceeds the recognized cost of attendance at the institution where the student enrolls. Public funds are defined to include Arkansas Department of Higher Education (ADHE) scholarships and grants, state general revenues, tuition, or local tax revenue. All postsecondary institutions shall report to ADHE the total amount of financial aid from all sources for any student who receives an award from an ADHE program. When a student receives a total aid package that includes public funds and exceeds the cost of attendance, the institution shall repay public funds in the amount exceeding total cost of attendance. Such funds repaid shall be credited to the Higher Education Grants Fund Account.

1 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
3 PROVISION. Upon certification by the Director of the Department of Higher
4 Education that transfers are needed to make maximum utilization of funds and
5 appropriations provided for financial aid programs, and with the approval of
6 the Chief Fiscal Officer of the State and a review by the Arkansas Legislative
7 Council, funds and appropriations may be transferred between financial aid
8 programs, except that funds and appropriations may not be transferred for such
9 purposes from either the Governor's Scholars Program or the Academic Challenge
10 Scholarships Program in excess of \$1,000,000 in the aggregate in either fiscal

27 order to provide timely payments under financial aid appropriations made in
28 this Act, the Chief Fiscal Officer of the State is authorized to provide loans
29 from the Budget Stabilization Trust Fund to make available all funds
30 attributable to the financial aid programs under the then current official
31 revenue estimates. In the event of an unanticipated state revenue shortfall,
32 any such loans remaining at the end of a fiscal year shall be repaid from
33 revenues distributed in the first two months of the next fiscal year. Funds
34 for appropriations made in this Act for purposes other than financial aid
35 shall not be affected by the application of this provision.

1 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORK FORCE
3 2000 DEVELOPMENT FUND PROCEDURES. After the amounts to be made available to
4 the various technical colleges have been determined ~~by the State Board of~~
5 ~~Higher Education under the provisions of Act 1244 of 1991 and Act 1246 of~~
6 ~~1991, and upon the review and approval of the Chief Fiscal Officer of the~~

19 and Community College System for which Work Force 2000 Development Fund monies
20 are determined by law, ~~or the State Board of Higher Education, or vice versa~~
21 then the actual amount of support from the Work Force 2000 Development Fund in
22 the preceding fiscal year for such educational institution shall be made
23 available ~~irregardless~~ irrespective of any other provision of law which sets
24 out maximum levels of support from such fund.

26 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUILDING
28 MAINTENANCE FUND. After the sum of \$13,200,000 has been deposited into the
29 Higher Education Building Maintenance Fund, the next \$10,000,000 or so much as
30 is collected, is to be transferred to the Research Development Fund there to
31 be used as provided by law.

33 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO
35 EXPENDITURES. Proceeds derived from the repayment of loans as authorized in
36 Item (03) of Section 6 of this Act for the Math/Science Teacher Loan Awards

1 Program shall be deposited into the State Treasury as "Refunds to
2 Expenditures."

3

4 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
6 FORWARD. The balance of the funds and appropriations as provided in Section 6
7 of this Act for the Governor's Scholars Program and the Academic Challenge
8 Scholarships Program which remain on June 30, ~~1998~~ 2000, shall be carried
9 forward and made available for the same purpose for the fiscal year ending
10 June 30, ~~1999~~ 2001.

11

12 SECTION 22. SPECIAL LANGUAGE. NATIONAL GUARD TUITION ASSISTANCE PROGRAM. In
13 addition to any other provisions of law, any student who receives assistance
14 from the appropriation made for the "National Guard Tuition Assistance
15 Program" in this Act shall repay any loans and/or assistance if the student
16 does not receive an Honorable Discharge.

17

18 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GOVERNOR'S
20 SCHOLARS PROGRAM. Should the funding of Governor's Scholars Program exceed the
21 funding level of the previous fiscal year ~~ending June 30, 1997,~~ and the number
22 of scholarships awarded increases to 200 or more ~~as a result of the actions of~~
23 ~~the Eighty First General Assembly,~~ the Department of Higher Education shall
24 make every effort to assure a geographic distribution of the awards without
25 compromising the academic criteria established for such awards.

26

27 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HIGHER
29 EDUCATION FORMULA DEVELOPMENT. The Department of Higher Education will work
30 with the state college and university president's council to review, revise
31 and develop funding formulae which will, in principle, seek to provide fair
32 and equitable state support to all postsecondary students across the state,
33 regardless of the state institution attended, while at the same time
34 recognizing (a) the different needs for lower level, upper level, and graduate
35 level instruction at the various institutions, (b) the requirements for
36 specialized equipment and labs and smaller class sizes in some disciplines and

1 (c) unique missions, such as agricultural extension services, research,
2 medical sciences, workforce development, and public service; and (d) growth,
3 economies of scale and other appropriate factors. The formula will be
4 developed in consensus with the state college and university president's
5 council and presented to the State Higher Education Coordinating Board and the
6 Joint Budget Committee of the General Assembly for review.

7
8 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TUITION
10 ADJUSTMENT FUND. (a) HIGHER EDUCATION TUITION ADJUSTMENT FUND. The Higher
11 Education Tuition Adjustment Fund is hereby created upon the books of the
12 State Treasurer, State Auditor, and Chief Fiscal Officer of the State. The
13 fund shall consist of such revenues as are allocated to it by law.

14 (b) PURPOSE OF THE FUND. It is the intent of the Arkansas General Assembly
15 that this fund ensures that bonafide Arkansas income taxpayers and their
16 dependents who are residents of a bordering state in a contiguous county to
17 the Arkansas State line which is contiguous to a county where an institution of
18 higher education is located receive the same higher education opportunities as
19 all other said taxpayers. In establishing this policy, it is the intent of
20 the General Assembly that taxpayers should have affordable access to the
21 state's higher education institutions.

22 Further, the Arkansas Department of Higher Education will require each
23 institution to track and report the number of qualifying students each year.
24 A list of students who benefit from the out-of-state tuition waiver including
25 their social security number or their Arkansas taxpaying parents' or
26 guardians' names and social security numbers will be furnished by the Arkansas
27 Department of Higher Education to the Department of Finance and Administration
28 for confirmation that they or their parents are employed in Arkansas at a wage
29 in excess of five thousand five hundred dollars (\$5,500) per annum.

30 Documentation should be either an official W-2 form from an Arkansas employer
31 reflecting wages of at least five thousand five hundred dollars (\$5,500) in
32 the tax year prior to enrollment in college; or official employer verification
33 of a current year salary minimum of at least five thousand five hundred
34 dollars (\$5,500) which the college will keep on file for enrollment audit
35 purposes.

36 (c) APPROPRIATION TRANSFER PROCEDURES. The Director of the Arkansas

1 Department of Higher Education shall determine the difference between the
2 amount of tuition revenue which would have been generated by charging the
3 State Board of Higher Education approved out-of-state tuition rate to said
4 students as compared to approved in-state or out-of-district rate. Upon such
5 determination, the Director of the Arkansas Department of Higher Education
6 shall certify to the Chief Fiscal Officer of the State and the State Treasurer
7 such amounts as are required to be transferred from the Higher Education
8 Tuition Adjustment Fund. Upon receiving such certification, the Chief Fiscal
9 Officer of the State and the State Treasurer shall cause to be transferred the
10 necessary funds and appropriation to the fund account of the institution
11 receiving such certification from the Director of the Arkansas Department of
12 Higher Education. In order to provide funding for the appropriation set out
13 in Item (15 14) of Section 6 of this Act, the Chief Fiscal Officer of the
14 State shall transfer to the Higher Education Tuition Adjustment Fund from the
15 Higher Education Grants Fund Account \$250,000 for each year of the biennium.
16

17 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOVING
19 EXPENSES. Arkansas Code 19-4-522 is amended by inserting an additional
20 subsection at the end thereof to read as follows:

21 "(e) Notwithstanding Arkansas Code 19-4-522 or any other law to the
22 contrary state-supported colleges and universities may utilize maintenance and
23 operation appropriations for the payment of moving expenses of employees,
24 including new hires."
25

26 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OUT-OF-
28 STATE TUITION WAIVER. The Board of Trustees of any institution of higher
29 education may waive the out-of-state portion of any full tuition scholarship
30 for any full-time student which is provided by unrestricted funds of the
31 institution. Such part as is waived shall not be considered as an expenditure
32 by any regulation of the ~~Board of Arkansas~~ Higher Education Coordinating
33 Board.
34

35 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COLLEGE

1 SAVINGS BONDS. The Department of Higher Education shall adopt rules and
 2 regulations for the allocation of the funds reappropriated for the development
 3 of projects at State Institutions of Higher Education and the payment of
 4 project costs and expenses of the issuance of the bonds of the Arkansas
 5 College Savings General Obligation Bonds Program ~~by the Eighty-First General~~
 6 ~~Assembly~~ to ensure that funds are allocated and expended in a manner
 7 consistent with the provisions of the Internal Revenue Code applicable to the
 8 Arkansas College Savings General Obligation Bond Program (Program). The funds
 9 reappropriated for the development of projects at State Institutions of Higher
 10 Education and the payment of project costs and expenses of the issuance of the
 11 bonds of the Arkansas College Savings General Obligation Bonds Program ~~by the~~
 12 ~~Eighty-First General Assembly~~ shall be allocated and expended pursuant to the
 13 provisions of Arkansas Code 6-62-701 et. seq. and other laws of this State.
 14 The expenditure and allocation of funds shall be exempt from any other
 15 provisions of state law which conflicts with any provision of the rules and
 16 regulations which rules and regulations are required to ensure the compliance
 17 of the Program with the applicable provisions of the Internal Revenue Code.

18

19 SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COLLEGE
 21 SAVINGS BONDS LIMITATIONS. Arkansas Code 6-62-708 is amended to read as
 22 follows: "The total principal amount of bonds to be issued during any fiscal
 23 biennium shall not exceed three-hundred million dollars (\$300,000,000), nor
 24 shall the principal amount of bonds outstanding at any time have debt service
 25 requirements in excess of twenty-four million dollars (\$24,000,000) in any one
 26 fiscal year from all sources."

27

28 SECTION 30. APPROPRIATION. NATIONAL GUARD TUITION ASSISTANCE PROGRAM.
 29 *There is hereby appropriated, to the Department of Higher Education, to be*
 30 *payable from the Higher Education Grants Fund Account, for tuition assistance*
 31 *payments of the State Military Department, for the biennial period ending June*
 32 *30, 2001, the sum of \$750,000.*

33

34 SECTION 31. APPROPRIATION - HEALTH EDUCATION GRANTS. *There is hereby*
 35 *appropriated, to the Department of Higher Education, to be payable from the*
 36 *Higher Education Grants Fund Account, for payments of the contracts with*

1 participating out-of-state institutions of higher learning in the fields of
 2 dentistry, optometry, osteopathy, veterinary medicine, chiropractic and
 3 podiatry for the education of Arkansas citizens by the Arkansas Department of
 4 Higher Education for the biennial period ending June 30, 2001, the following:

16 SECTION 32. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 18 OF HIGHER EDUCATION GRANTS FUND APPROPRIATIONS - HEALTH EDUCATION GRANTS. Upon
 19 certification to and with the approval of the Chief Fiscal Officer of the
 20 State, surplus funds and appropriations may be transferred between the
 21 appropriations provided for "Health Education Grants" by this Act by the
 22 Eighty-Second General Assembly for Dental Aid, Optometry Aid, Veterinary Aid,
 23 Podiatry Aid, Chiropractic Aid and Osteopathic Aid.

25 SECTION 33. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 27 FORWARD - HEALTH EDUCATION GRANTS. The balance of the funds and
 28 appropriations as provided for "Health Education Grants" in this Act which
 29 remain on June 30, 2000, shall be carried forward and made available for the
 30 same purposes for the fiscal year ending June 30, 2001.

32 SECTION 34. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REPORTING
 34 REQUIREMENTS - HEALTH EDUCATION GRANTS. The Arkansas Department of Higher
 35 Education shall annually compile information, as described herein, on students
 36 who receive financial aid through the appropriations for health education

1 grants provided for in this Act. Such information shall include the number of
2 students receiving financial aid under each line item of the appropriation
3 made for "Health Education Grants" in this Act, the name of each out-of-state
4 school which each student is attending or has attended, and, if available, the

13 EDUCATION GRANTS - PRIORITIES. Effective July 1, 1999, the Arkansas Higher
14 Education Coordinating Board, after consulting with the recognized
15 associations of each of the applicable medical professions and other
16 interested persons, shall determine the priorities for the applicable programs
17 enumerated in the appropriation made for "Health Education Grants" in this Act
18 and the Arkansas Department of Higher Education, if necessary, shall re-adjust
19 the number of freshman positions to be funded for each applicable program
20 based upon the priorities determined by the board.

22 SECTION 36. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HEALTH
24 EDUCATION GRANTS - STUDY. The Arkansas Higher Education Coordinating Board
25 shall conduct a study during the 1999-2001 biennium as to the future need for
26 health care providers in dentistry, veterinary medicine, chiropractic,
27 optometry, osteopathy and podiatry in Arkansas and shall report its findings
28 to the General Assembly on or before October 1, 2000.

29
30 SECTION 37. SPECIAL LANGUAGE. In accordance with the uniform reporting and
31 auditing of intercollegiate athletic expenditures of state-supported
32 institutions of higher education, maintenance of facilities expenditures
33 related to all intercollegiate teams and spirit groups, excluding bands, shall
34 be reported as actual costs of operating such athletic facilities or a
35 proration of actual costs based on athletic usage.

36

1 SECTION 38. APPROPRIATIONS. There is hereby appropriated, to the Department
 2 of Higher Education, to be payable from the General Improvement Fund or its
 3 successor fund or fund accounts, for grant(s) for the operational costs of the
 4 Arkansas Association of Two-Year Colleges WorkForce Training Consortium (WFTC)
 5 by the Department of Higher Education for the biennial period ending June 30,
 6 2001, the following:

13 SECTION 39. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
 14 by this act shall be limited to the appropriation for such agency and funds
 15 made available by law for the support of such appropriations; and the
 16 restrictions of the State Purchasing Law, the General Accounting and Budgetary
 17 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
 18 and Restrictions Act, or their successors, and other fiscal control laws of
 19 this State, where applicable, and regulations promulgated by the Department of
 20 Finance and Administration, as authorized by law, shall be strictly complied
 21 with in disbursement of said funds.

23 SECTION 40. LEGISLATIVE INTENT. It is the intent of the General Assembly
 24 that any funds disbursed under the authority of the appropriations contained
 25 in this act shall be in compliance with the stated reasons for which this act
 26 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 27 and Legislative Recommendations contained in the budget manuals prepared by
 28 the Department of Finance and Administration, letters, or summarized oral
 29 testimony in the official minutes of the Arkansas Legislative Council or Joint
 30 Budget Committee which relate to its passage and adoption.

32 SECTION 41. CODE. All provisions of this Act of a general and permanent
 33 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
 34 Code Revision Commission shall incorporate the same in the Code.

36 SECTION 42. SEVERABILITY. If any provision of this act or the application

1 thereof to any person or circumstance is held invalid, such invalidity shall
2 not affect other provisions or applications of the act which can be given
3 effect without the invalid provision or application, and to this end the
4 provisions of this act are declared to be severable.

5
6 SECTION 43. GENERAL REPEALER. All laws and parts of laws in conflict with
7 this act are hereby repealed.

8
9 SECTION 44. EMERGENCY CLAUSE. It is hereby found and determined by the
10 Eighty-second General Assembly, that the Constitution of the State of Arkansas
11 prohibits the appropriation of funds for more than a two (2) year period; that
12 the effectiveness of this Act on July 1, 1999 is essential to the operation of
13 the agency for which the appropriations in this Act are provided, and that in
14 the event of an extension of the Regular Session, the delay in the effective
15 date of this Act beyond July 1, 1999 could work irreparable harm upon the
16 proper administration and provision of essential governmental programs.
17 Therefore, an emergency is hereby declared to exist and this Act being
18 necessary for the immediate preservation of the public peace, health and
19 safety shall be in full force and effect from and after July 1, 1999.
