SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FIREARMS 19 20 INVESTIGATIVE UNIT/FIREARMS TRACING AND IDENTIFICATION. The Department of Arkansas State Police and the Arkansas State Crime Laboratory shall enter into 21 22 an interagency agreement for the implementation and operation of each agencies 23 respective component and functions involving a joint program regarding 24 Firearms Investigation and Firearms Tracing and Identification. SECTION 18. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 10 by this act shall be limited to the appropriation for such agency and funds 11 12 made available by law for the support of such appropriations; and the 13 restrictions of the State Purchasing Law, the General Accounting and Budgetary 14 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures 15 and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of 16 Finance and Administration, as authorized by law, shall be strictly complied 17 18 with in disbursement of said funds.

20 SECTION 19. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained 21 22 in this act shall be in compliance with the stated reasons for which this act 23 was adopted, as evidenced by the Agency Requests, Executive Recommendations 24 and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral 25 26 testimony in the official minutes of the Arkansas Legislative Council or Joint 27 Budget Committee which relate to its passage and adoption.

SECTION 20. CODE. All provisions of this Act of a general and permanent
nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
Code Revision Commission shall incorporate the same in the Code.

33 SECTION 21. SEVERABILITY. If any provision of this act or the application 34 thereof to any person or circumstance is held invalid, such invalidity shall 35 not affect other provisions or applications of the act which can be given 36 effect without the invalid provision or application, and to this end the

1	provisions of this act are declared to be severable.
2 3	SECTION 22. GENERAL REPEALER. All laws and parts of laws in conflict with
4 5	this act are hereby repealed.
6	SECTION 23. EMERGENCY CLAUSE. It is hereby found and determined by the
7	Eighty-second General Assembly, that the Constitution of the State of Arkansas
8	prohibits the appropriation of funds for more than a two (2) year period; that
9	the effectiveness of this Act on July 1, 1999 is essential to the operation of
10	the agency for which the appropriations in this Act are provided, and that in
11	the event of an extension of the Regular Session, the delay in the effective
12	date of this Act beyond July 1, 1999 could work irreparable harm upon the
13	proper administration and provision of essential governmental programs.
14	Therefore, an emergency is hereby declared to exist and this Act being
15	necessary for the immediate preservation of the public peace, health and
16	safety shall be in full force and effect from and after July 1, 1999.
