34 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUFFALO
 36 GNAT CONTROL PROGRAM. The Appropriation authorized for the Buffalo Gnat

30 SECTION 24. SPECIAL LANGUAGE. FUND TRANSFER - EQUINE INFECTIOUS ANEMIA.
31 The Executive Director of the Livestock and Poultry Commission, with the
32 approval of the Chief Fiscal Officer of the State, may transfer funds from the
33 Livestock and Poultry Equine Infectious Anemia Control Fund to the Livestock
34 and Poultry Fund Account.

35
36 SECTION 25. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized

1 by this act shall be limited to the appropriation for such agency and funds
2 made available by law for the support of such appropriations; and the
3 restrictions of the State Purchasing Law, the General Accounting and Budgetary
4 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
5 and Restrictions Act, or their successors, and other fiscal control laws of
6 this State, where applicable, and regulations promulgated by the Department of
7 Finance and Administration, as authorized by law, shall be strictly complied
8 with in disbursement of said funds.

9
10 SECTION 26. LEGISLATIVE INTENT. It is the intent of the General Assembly
11 that any funds disbursed under the authority of the appropriations contained
12 in this act shall be in compliance with the stated reasons for which this act
13 was adopted, as evidenced by the Agency Requests, Executive Recommendations
14 and Legislative Recommendations contained in the budget manuals prepared by
15 the Department of Finance and Administration, letters, or summarized oral
16 testimony in the official minutes of the Arkansas Legislative Council or Joint
17 Budget Committee which relate to its passage and adoption.

18
19 SECTION 27. CODE. All provisions of this Act of a general and permanent
20 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
21 Code Revision Commission shall incorporate the same in the Code.

22
23 SECTION 28. SEVERABILITY. If any provision of this act or the application
24 thereof to any person or circumstance is held invalid, such invalidity shall
25 not affect other provisions or applications of the act which can be given
26 effect without the invalid provision or application, and to this end the
27 provisions of this act are declared to be severable.

28
29 SECTION 29. GENERAL REPEALER. All laws and parts of laws in conflict with
30 this act are hereby repealed.

31
32 SECTION 30. EMERGENCY CLAUSE. It is hereby found and determined by the
33 Eighty-second General Assembly, that the Constitution of the State of Arkansas
34 prohibits the appropriation of funds for more than a two (2) year period; that
35 the effectiveness of this Act on July 1, 1999 is essential to the operation of
36 the agency for which the appropriations in this Act are provided, and that in

1 the event of an extension of the Regular Session, the delay in the effective
2 date of this Act beyond July 1, 1999 could work irreparable harm upon the
3 proper administration and provision of essential governmental programs.
4 Therefore, an emergency is hereby declared to exist and this Act being
5 necessary for the immediate preservation of the public peace, health and
6 safety shall be in full force and effect from and after July 1, 1999.
