Arkansas Code 3-3-210 is amended to read as follows: "3-3-210. Sale on Sunday or early weekday mornings. 23 24 (a) Any person who shall sell intoxicating alcoholic liquor on Sunday, except as such sales are authorized by § 3-9-215 and § 3-9-401 et seq., or 25 between 1:00 a.m. and 7:00 a.m. on week days shall be guilty of a misdemeanor 26 and for the first offense be punishable by a fine of not less than one hundred 27 28 dollars (\$100) nor more than two hundred fifty dollars (\$250), and for the 29 second and subsequent offenses he shall be guilty of a misdemeanor and punishable by a fine of not less than two hundred fifty dollars (\$250) nor 30 31 more than five hundred dollars (\$500) or by imprisonment in the county jail for not less than ten (10) days nor more than six (6) months, or both so fined 32 and imprisoned in the discretion of the court or jury. 33 (b) As a further exception to the Sunday sales prohibition set out 34 above, counties and cities in the state in which the sale of alcoholic 35 36 beverages is authorized may, by the adoption of an ordinance by the county

- 33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 34 Revision Commission shall incorporate the same in the Code.
