SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL

For the purpose of providing necessary allowances for housing and 1 ALLOWANCES. 2 other unusual expenses incurred by or in behalf of the athletic director, 3 assistant athletic directors, head coaches, and assistant coaches at Arkansas 4 State University, the Board of Trustees may make special allowances available therefor in such amounts as the Board of Trustees may determine as justified, 5 an equitable allowance in view of the unusual and exacting duties of said 6 7 athletic director, assistant athletic directors, head coaches, and assistant 8 coaches, and for the purpose of providing such allowances, the Board of 9 Trustees is authorized to expend from the auxiliary income of the Arkansas State University, which is derived from athletic event receipts, an amount not 10 11 to exceed twenty thousand dollars (\$20,000) in the aggregate for such purposes 12 during each year of the 1997-99 1999-2001 biennium for the athletic director 13 and head coaches, and ten thousand dollars (\$10,000) in the aggregate for such purposes during the 1997-99 1999-2001 biennium for the assistant athletic 14 15 directors and assistant coaches. Provided that any such allowances shall be in 16 addition to the regular salary of such athletic director, assistant athletic directors, head coaches and assistant coaches, as established herein provided 17 18 that the amount of such allowance shall not exceed ten thousand dollars 19 (\$10,000) per annum for any one salaried position. Further, if the special 20 allowance funds authorized herein are utilized Arkansas State University shall report annually to the Legislative Joint Auditing Committee the exact 21 22 disposition of the those special allowance funds authorized herein. 23 24 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE 25 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REALLOCATION OF 26 RESOURCES. Upon determination by the President of Arkansas State University 27 that a reallocation of resources for purposes of reorganization or 28 consolidation of administrative functions within the university is necessary 29 for efficient and effective operations of the university, the president, with approval of the Arkansas State University Board of Trustees, may have the 30 31 authority to transfer positions, appropriations and related funds between campuses, divisions, branches, and other budgetary units of Arkansas State 32 University. The transfers of positions, programs, or activities shall be used 33 34 for those purposes for which the appropriations were approved by the General 35 Assembly. The transfers, consolidation, or reorganization which involve academic programs shall be reviewed by the Department of Higher Education and 36

3 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR 4 PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LEASES.

Notwithstanding any law to the contrary, the Board of Trustees of Arkansas State University may hereafter lease facilities or operations for room and board purposes in any manner and upon terms the board deems to be in the best interest of the university. Action taken under this act shall be by written resolution adopted by at least a majority of the members of the board.

11 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by 12 this act shall be limited to the appropriation for such agency and funds made 13 available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures 14 15 Law, the Revenue Stabilization Law, the Regular Salary Procedures and 16 Restrictions Act, the Higher Education Expenditures Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and 17 18 regulations promulgated by the Department of Finance and Administration, as 19 authorized by law, shall be strictly complied with in disbursement of said 20 funds.

SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 10. CODE. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 11. SEVERABILITY. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall

1	not affect other provisions or applications of the act which can be given
2	effect without the invalid provision or application, and to this end the
3	provisions of this act are declared to be severable.

5	SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with
6	this act are hereby repealed.
7	
8	SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
9	Eighty-second General Assembly, that the Constitution of the State of Arkansas
10	prohibits the appropriation of funds for more than a two (2) year period; that
11	the effectiveness of this Act on July 1, 1999 is essential to the operation of
12	the agency for which the appropriations in this Act are provided, and that in
13	the event of an extension of the Regular Session, the delay in the effective
14	date of this Act beyond July 1, 1999 could work irreparable harm upon the
15	proper administration and provision of essential governmental programs.
16	Therefore, an emergency is hereby declared to exist and this Act being
17	necessary for the immediate preservation of the public peace, health and
18	safety shall be in full force and effect from and after July 1, 1999.
