20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Commission on Law Enforcement Standards and Training for the 1999-2001
24 biennium, the following maximum number of regular employees whose salaries
25 shall be governed by the provisions of the Uniform Classification and
26 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
27 laws amendatory thereto. Provided, however, that any position to which a
28 specific maximum annual salary is set out herein in dollars, shall be exempt
29 from the provisions of said Uniform Classification and Compensation Act. All
30 persons occupying positions authorized herein are hereby governed by the
31 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
32 Code §21-5-101), or its successor.

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Any unexpended balances of appropriation and funds authorized for Capital Outlay in Section 2 of this Act on June 30, ~~1998~~ 2000, shall be carried forward and made available for the same purpose during the fiscal year ending June 30, ~~1999~~ 2001.

SECTION 7. SPECIAL LANGUAGE. UNIFORMS. After seeking prior review by the Arkansas Legislative Council or Joint Budget Committee and approval by the

1 Chief Fiscal Officer of the State, the Commission on Law Enforcement Standards
2 and Training shall be exempt from Arkansas Code 19-6-109 (c) for the purpose
3 of buying uniforms for students. The amount spent for the purchase of
4 uniforms in any one year shall be limited to \$40,000.

5
6 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
7 this act shall be limited to the appropriation for such agency and funds made
8 available by law for the support of such appropriations; and the restrictions
9 of the State Purchasing Law, the General Accounting and Budgetary Procedures
10 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
11 Restrictions Act, or their successors, and other fiscal control laws of this
12 State, where applicable, and regulations promulgated by the Department of
13 Finance and Administration, as authorized by law, shall be strictly complied
14 with in disbursement of said funds.

15
16 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
17 that any funds disbursed under the authority of the appropriations contained
18 in this act shall be in compliance with the stated reasons for which this act
19 was adopted, as evidenced by the Agency Requests, Executive Recommendations
20 and Legislative Recommendations contained in the budget manuals prepared by
21 the Department of Finance and Administration, letters, or summarized oral
22 testimony in the official minutes of the Arkansas Legislative Council or Joint
23 Budget Committee which relate to its passage and adoption.

25 SECTION 10. CODE. All provisions of this Act of a general and permanent
26 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
27 Code Revision Commission shall incorporate the same in the Code.

28
29 SECTION 11. SEVERABILITY. If any provision of this act or the application
30 thereof to any person or circumstance is held invalid, such invalidity shall
31 not affect other provisions or applications of the act which can be given
32 effect without the invalid provision or application, and to this end the
33 provisions of this act are declared to be severable.

34
35 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with
36 this act are hereby repealed.

1 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
2 Eighty-second General Assembly, that the Constitution of the State of Arkansas
3 prohibits the appropriation of funds for more than a two (2) year period; that
4 the effectiveness of this Act on July 1, 1999 is essential to the operation of
5 the agency for which the appropriations in this Act are provided, and that in
6 the event of an extension of the Regular Session, the delay in the effective
7 date of this Act beyond July 1, 1999 could work irreparable harm upon the
8 proper administration and provision of essential governmental programs.
9 Therefore, an emergency is hereby declared to exist and this Act being
10 necessary for the immediate preservation of the public peace, health and
11 safety shall be in full force and effect from and after July 1, 1999.
