20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
23 the University of Arkansas at Pine Bluff for the 1999-2001 biennium, the
24 following maximum number of regular employees whose salaries shall be governed
25 by the provisions of the Uniform Classification and Compensation Act (Arkansas
26 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
27 Provided, however, that any position to which a specific maximum annual salary
28 is set out herein in dollars, shall be exempt from the provisions of said
29 Uniform Classification and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

 33 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 34 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
 35 ALLOWANCES. The Board of Trustees, after seeking prior review by the Arkansas
 36 Legislative Council, may approve the employment of competent scientists with

1 extraordinary research capabilities to conduct research in the Biomedical
2 Research Center that will be established at the University of Arkansas at Pine
3 Bluff. Further, that the Board of Trustees of the University of Arkansas be
4 authorized to approve salaries for scientists up to, but not to exceed, one
5 and one-half of that portion of the Distinguished Professor line item maximum
6 authorized by the General Assembly to be paid from University of Arkansas at
7 Pine Bluff funds.

8
9 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
10 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JENKINS CENTER.
11 Of the funds appropriated in Section 3, the sum of \$263,741 in the ~~1997-98~~
12 1999-2000 fiscal year and \$263,741 in the ~~1998-99~~ 2000-2001 fiscal year shall
13 be used to provide support to the Jenkins Center in Pine Bluff. Provided,
14 however, such funds shall be used to conduct and maintain a University
15 training program in cooperation with the Jenkins Center. Provided, further,
16 any reductions in funding for appropriation provided in Section 3 shall be
17 proportionately applied to the funds set out herein for support.

19 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
21 PAYMENT. *The University of Arkansas at Pine Bluff (UAPB) may, from funds*
22 *appropriated herein in either year of the biennium, purchase a private*
23 *lifetime annuity or other periodic payment plan to discharge the obligations*
24 *of UAPB and the State of Arkansas in the case of Thelma Gant, Guardian of*
25 *Jerome Morgan vs. University of Arkansas at Pine Bluff, Arkansas State Claim*
26 *Commission No. 86-376-cc to make annual payments of \$15,000 per year in*
27 *monthly installments or other periodic payments to the guardian of Jerome*
28 *Morgan. The total amount shall not exceed \$225,000.*

29
30 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
31 this act shall be limited to the appropriation for such agency and funds made
32 available by law for the support of such appropriations; and the restrictions
33 of the State Purchasing Law, the General Accounting and Budgetary Procedures
34 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
35 Restrictions Act, the Higher Education Expenditures Restrictions Act, or their
36 successors, and other fiscal control laws of this State, where applicable, and

1 regulations promulgated by the Department of Finance and Administration, as
2 authorized by law, shall be strictly complied with in disbursement of said
3 funds.

4
5 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
6 that any funds disbursed under the authority of the appropriations contained
7 in this act shall be in compliance with the stated reasons for which this act
8 was adopted, as evidenced by the Agency Requests, Executive Recommendations
9 and Legislative Recommendations contained in the budget manuals prepared by
10 the Department of Finance and Administration, letters, or summarized oral
11 testimony in the official minutes of the Arkansas Legislative Council or Joint
12 Budget Committee which relate to its passage and adoption.

13
14 SECTION 10. CODE. All provisions of this Act of a general and permanent
15 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
16 Code Revision Commission shall incorporate the same in the Code.

17
18 SECTION 11. SEVERABILITY. If any provision of this act or the application
19 thereof to any person or circumstance is held invalid, such invalidity shall
20 not affect other provisions or applications of the act which can be given
21 effect without the invalid provision or application, and to this end the
22 provisions of this act are declared to be severable.

23
24 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with
25 this act are hereby repealed.

26
27 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
28 Eighty-second General Assembly, that the Constitution of the State of Arkansas
29 prohibits the appropriation of funds for more than a two (2) year period; that
30 the effectiveness of this Act on July 1, 1999 is essential to the operation of
31 the agency for which the appropriations in this Act are provided, and that in
32 the event of an extension of the Regular Session, the delay in the effective
33 date of this Act beyond July 1, 1999 could work irreparable harm upon the
34 proper administration and provision of essential governmental programs.
35 Therefore, an emergency is hereby declared to exist and this Act being
36 necessary for the immediate preservation of the public peace, health and

1 safety shall be in full force and effect from and after July 1, 1999.
