

(c) If a technical college, community college, two year college, or 8 9 satellite campus of a community college for which a tax is dedicated or levied under this section thereafter becomes a branch of an existing institution of 10 higher education, the tax dedicated or levied under this section shall 11 continue to be dedicated and levied for the use and benefit of the branch, 12 13 unless reduced or repealed as authorized under this section. 14 (d) A county sales or use tax dedicated or levied under this section 15 may also be dedicated or levied in part for capital improvements to, or the maintenance and operation of, any public institution of higher education 16 located in the county." 17 18 19 SECTION 2. All provisions of this act of a general and permanent nature 20 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 21 Revision Commission shall incorporate the same in the Code. 22 23 SECTION 3. If any provision of this act or the application thereof to 24 any person or circumstance is held invalid, such invalidity shall not affect 25 other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this 26 27 act are declared to be severable. 28 29 SECTION 4.
