All provisions of this act of a general and permanent nature 29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code. 30 31 SECTION 3. If any provision of this act or the application thereof to 32 any person or circumstance is held invalid, such invalidity shall not affect 33 other provisions or applications of the act which can be given effect without 34 35 the invalid provision or application, and to this end the provisions of this act are declared to be severable. 36
