## For An Act To Be Entitled

9 "AN ACT TO AMEND ARKANSAS CODE 27-15-3002 TO WAIVE THE  
10 FEE FOR THE INITIAL LICENSE PLATE FOR CIVIL AIR PATROL  
11 MEMBERS WITH MORE THAN THREE (3) YEARS OF SERVICE IN  
12 THE CIVIL AIR PATROL; AND FOR OTHER PURPOSES."

15 FOR C. A. P. MEMBERS WITH MORE THAN THREE

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 *SECTION 1. Arkansas Code § 27-15-3002(b), regarding the eligibility for*  
24 *special license plates for the Civil Air Patrol, is amended to read as*  
25 *follows:*

26 *"(b)(1) Upon submitting proof of eligibility and complying with the*  
27 *state laws relating to registration and licensing of motor vehicles*  
28 *and the payment of thirty-five dollars (\$35.00) for the initial license plate, the*  
29 *applicant shall be issued a Civil Air Patrol license plate under this*  
30 *subchapter.*

31 ~~*(2) The thirty-five-dollar fee shall be deposited into the State*~~  
32 ~~*Central Services Fund as a direct revenue for the support of the Department of*~~  
33 ~~*Finance and Administration.*~~

34 ~~*(3)(2) Annual renewals of Civil Air Patrol license plates shall*~~  
35 ~~*be at the same fee as prescribed for regular motor vehicle license plates in §*~~  
36 ~~*27-14-601, and shall be disbursed accordingly."*~~

SECTION 2. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
