DISBURSEMENT CONTROLS. - 17 and Legislative Recommendations contained in the budget manuals prepared by

- SECTION 4. CODE. All provisions of this Act of a general and permanent

- SECTION 5. SEVERABILITY. If any provision of this act or the application
- 27 thereof to any person or circumstance is held invalid, such invalidity shall

- 32 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict with

- 35 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
- 36 <u>Eighty-second General Assembly</u>, that the Constitution of the State of Arkansas

1 prohibits the appropriation of funds for more than a two (2) year period; that

- 2 the effectiveness of this Act on July 1, 1999 is essential to the operation of
- 3 the agency for which the appropriations in this Act are provided, and that in
- 4 <u>the event of an extension of the Regular Session, the delay in the effective</u>
- 5 <u>date of this Act beyond July 1, 1999 could work irreparable harm upon the</u>
- 6 proper administration and provision of essential governmental programs.
- 7 Therefore, an emergency is hereby declared to exist and this Act being
- 8 <u>necessary for the immediate preservation of the public peace, health and</u>
- 9 safety shall be in full force and effect from and after July 1, 1999.
