20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
23 established for the Arkansas Geological Commission for the 1999-2001 biennium,
24 the following maximum number of regular employees whose salaries shall be
25 governed by the provisions of the Uniform Classification and Compensation Act
26 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
27 thereto. Provided, however, that any position to which a specific maximum
28 annual salary is set out herein in dollars, shall be exempt from the
29 provisions of said Uniform Classification and Compensation Act. All persons
30 occupying positions authorized herein are hereby governed by the provisions of
31 the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
32 101), or its successor.

 28 SECTION 11. APPROPRIATIONS - CASH - GEOLOGY MUSEUM. There is hereby
 29 appropriated, to the Arkansas Geological Commission, to be payable from cash
 30 funds as defined by Arkansas Code 19-4-801 of the Arkansas Geological
 31 Commission, for museum expenses of the Arkansas Geological Commission -
 32 Geology Museum for the biennial period ending June 30, 2001, the following:

2 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
3 by this act shall be limited to the appropriation for such agency and funds
4 made available by law for the support of such appropriations; and the
5 restrictions of the State Purchasing Law, the General Accounting and Budgetary
6 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
7 and Restrictions Act, or their successors, and other fiscal control laws of
8 this State, where applicable, and regulations promulgated by the Department of
9 Finance and Administration, as authorized by law, shall be strictly complied
10 with in disbursement of said funds.

11
12 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General Assembly
13 that any funds disbursed under the authority of the appropriations contained
14 in this act shall be in compliance with the stated reasons for which this act
15 was adopted, as evidenced by the Agency Requests, Executive Recommendations
16 and Legislative Recommendations contained in the budget manuals prepared by
17 the Department of Finance and Administration, letters, or summarized oral
18 testimony in the official minutes of the Arkansas Legislative Council or Joint
19 Budget Committee which relate to its passage and adoption.

20
21 SECTION 14. CODE. All provisions of this Act of a general and permanent
22 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
23 Code Revision Commission shall incorporate the same in the Code.

24
25 SECTION 15. SEVERABILITY. If any provision of this act or the application
26 thereof to any person or circumstance is held invalid, such invalidity shall
27 not affect other provisions or applications of the act which can be given
28 effect without the invalid provision or application, and to this end the
29 provisions of this act are declared to be severable.

30
31 SECTION 16. GENERAL REPEALER. All laws and parts of laws in conflict with
32 this act are hereby repealed.

33
34 SECTION 17. EMERGENCY CLAUSE. It is hereby found and determined by the
35 Eighty-second General Assembly, that the Constitution of the State of Arkansas
36 prohibits the appropriation of funds for more than a two (2) year period; that

1 the effectiveness of this Act on July 1, 1999 is essential to the operation of
2 the agency for which the appropriations in this Act are provided, and that in
3 the event of an extension of the Regular Session, the delay in the effective
4 date of this Act beyond July 1, 1999 could work irreparable harm upon the
5 proper administration and provision of essential governmental programs.
6 Therefore, an emergency is hereby declared to exist and this Act being
7 necessary for the immediate preservation of the public peace, health and
8 safety shall be in full force and effect from and after July 1, 1999.
