### For An Act To Be Entitled

9 "AN ACT TO AMEND ARKANSAS CODE 23-111-509 TO REQUIRE  
10 THE FILING OF SIMULCAST DOG-RACING CONTRACTS WITH THE  
11 RACING COMMISSION; AND FOR OTHER PURPOSES. "

### Subtitle

14 "TO AMEND ARKANSAS CODE 23-111-509 TO  
15 REQUIRE THE FILING OF SIMULCAST DOG-  
16 RACING CONTRACTS WITH THE RACING  
17 COMMISSION; AND FOR OTHER PURPOSES. "

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 23-111-509(a), regarding the disposition of  
23 money wagered at franchised dog-racing facilities, is amended to read as  
24 follows:

25 "(a)(1) Each franchise holder conducting a racing meet under the  
26 provisions of this chapter shall keep its books and records in such manner as  
27 to clearly show the total amount of moneys wagered on each and every race held  
28 or conducted at each meet and the disposition of the moneys.

29 (2) The franchise holder shall file with the commission a copy of  
30 each simulcast racing contract to which it is a party and the contract shall  
31 be filed within three (3) calendar days after each such contract is executed.  
32 Such contracts shall not be available to the general public, but shall be  
33 made available only to the Department of Finance and Administration, to the  
34 Arkansas Racing Commission, and to auditors with the Division of Legislative  
35 Audit."  
36

1 SECTION 2. All provisions of this act of a general and permanent nature  
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
3 Revision Commission shall incorporate the same in the Code.

4  
5 SECTION 3. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10  
11 SECTION 4. All laws and parts of laws in conflict with this act are  
12 hereby repealed.
