11 TO A STUDENT'S PARTICIPATION IN VOCATIONAL SERVICE
12 ORGANIZATIONS; AND FOR OTHER PURPOSES. "

15 "AN ACT TO ALLOW REIMBURSEMENT TO
16 TECHNICAL INSTITUTES, VO-TECH SCHOOLS,
17 AND OTHER SCHOOLS FOR EXPENSES RELATED
18 TO A STUDENT'S PARTICIPATION IN
19 VOCATIONAL SERVICE ORGANIZATIONS. "

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. (a) The Department of Workforce Education may reimburse
25 secondary vocational centers and other public school in Arkansas for dues,
26 membership fees, supplies, travel, lodging and other expenses related to a
27 student's participation in vocational student organizations.

28 (b) The amount allowed pursuant to this section shall be thirty-five
29 dollars (\$35) per student as documented by national and state membership
30 records.

31 (c) The Department of Workforce Education may disburse funds after the
32 final cut-off date for membership enrollments.

33 (d) The Department of Workforce Education shall promulgate rules and
34 regulations necessary for the implementation of this section.

35 (e) The provisions of this act shall be contingent on the appropriation
36 and funding necessary to allow the Department of Workforce Education to carry

1 out the duties assigned to it in this act.

2

3 SECTION 2. All provisions of this act of a general and permanent nature
4 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
5 Revision Commission shall incorporate the same in the Code.

6

7 SECTION 3. If any provision of this act or the application thereof to
8 any person or circumstance is held invalid, such invalidity shall not affect
9 other provisions or applications of the act which can be given effect without
10 the invalid provision or application, and to this end the provisions of this
11 act are declared to be severable.

12

13 SECTION 4. All laws and parts of laws in conflict with this act are
14 hereby repealed.
