23	SECTION 1. Operat	<u>ing expenses - Staff.</u>	
24	(a) The Office of the Prosecuting Attorney of the Twenty-second		
25	Judicial District shall receive not less than a contingent expense

15	District shall be allowed additional assistance and employees in each county		
16	upon appropriation of the quorum court and approval of the county judge in		
17	each respective county.

19	SECTION 2. All provisions of this act of a general and permanent nature		
20	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code		
21	Revision Commission shall incorporate the same in the Code.		
22			
23	SECTION 3. If any provision of this act or the application thereof to		
24	any person or circumstance is held invalid, such invalidity shall not affect		
25	other provisions or applications of the act which can be given effect without		
26	the invalid provision or application, and to this end the provisions of this		
27	act are declared to be severable.		
28			
29	SECTION 4. All laws and parts of laws in conflict with this act are		
30	hereby repealed.
