20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code 20-78-501(b) is amended to read as follows:	
23	"(b) The membership of the commission shall be as follows:	
24	(1) Three (3) members affiliated with child care provider	
25	agencies, organizations, or programs;	
26	(2) One (1) member affiliated with a Head Start program;	
27	(3) One (1) member affiliated with a HIPPY program;	
28	(4) One (1) member employed as an administrator by a public	
29	school district;	
30	(5) One (1) member employed by a public school district as a	
31	teacher with early childhood responsibilities;	
32	(6) The Director of the Department of Health or her designee;	
33 34	(7) One (1) member trained as early childhood education professionals;	
35	(8) One (1) member who are parents is a parent of a child who	
36	attends a child care program;

1	(9) The Director of the Vocational and Technical Division of the
2	Department of Education, or its successor, or his designee;
3	(10) The Director of the General Education Division of the
4	Department of Education or his designee;
5	(11) Two (2) members representing the business community who have
6	an interest in early childhood education;
7	$\frac{(13)}{(12)}$ One (1) member to be appointed by the The chair of the
8	House Subcommittee on Children and Youth of the House Committee on Aging,
9	Children and Youth, Legislative and Military Affairs or the chair's designee;
10	$\frac{(14)}{(13)}$ One (1) member to be appointed by the The chair of the
11	Senate Committee on Children and Youth or the chair's designee;
12	$\frac{(15)}{(14)}$ One (1) member to be appointed by the The chair of the
13	House Committee on Education or the chair's designee; and
14	$\frac{(16)}{(15)}$ One (1) member to be appointed by the The chair of the
15	Senate Committee on Education or the chair's designee."

17	SECTION 2. All provisions of this act of a general and permanent nature
18	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
19	Revision Commission shall incorporate the same in the Code.
20	
21	SECTION 3. If any provision of this act or the application thereof to
22	any person or circumstance is held invalid, such invalidity shall not affect
23	other provisions or applications of the act which can be given effect without
24	the invalid provision or application, and to this end the provisions of this
25	act are declared to be severable.
26	
27	SECTION 4. All laws and parts of laws in conflict with this act are
28	hereby repealed.
