22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code 6-18-1005(a)(6) is hereby amended to read as
25 follows:

26 "(6) Health services; ~~and~~ which shall include, but are not limited to,
27 the following:

28 (A) Students with special health care needs, including
29 chronically ill, medically fragile and technology dependent, and students with
30 other health impairments shall have an individualized health care plan;

31 (B) Invasive medical procedures required by students and provided
32 at the school shall be performed by trained, licensed personnel who are
33 licensed to perform the task subject to Arkansas Code 17-87-102(2)(d) or other
34 professional licensure statutes. The regular classroom teacher shall not
35 perform these tasks;

36 (C) Custodial health care services required by students under an

1 Individualized Healthcare Plan (IHP) shall be provided by trained school
2 employees other than the regular classroom teachers; and

3

4 SECTION 2. All provisions of this act of a general and permanent nature
5 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
6 Revision Commission shall incorporate the same in the Code.

7

8 SECTION 3. If any provision of this act or the application thereof to
9 any person or circumstance is held invalid, such invalidity shall not affect
10 other provisions or applications of the act which can be given effect without
11 the invalid provision or application, and to this end the provisions of this
12 act are declared to be severable.

13

14 SECTION 4. All laws and parts of laws in conflict with this act are
15 hereby repealed.
