21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code 20-8-102(b) is amended to read as follows:

24 "(b) The Health Services Commission shall be composed of the following
25 membership to be appointed by the Governor and confirmed by the Senate:

- 26 (1) A practicing physician;
27 (2) A representative of the Department of Human Services;
28 (3) A member of the Arkansas Hospital Association;
29 (4) A member of the Arkansas Health Care Association;
30 (5) A member of the Arkansas Chapter of the American Association

31 of Retired Persons;

32 (6) ~~A member of the Arkansas Association of Home Health Agencies~~
33 HomeCare Association of Arkansas;

34 (7) A consumer knowledgeable in business health insurance;

35 (8) A member of the Arkansas State Hospice Association;

36 ~~(8)(9) A member of the Arkansas Association of Residential Care~~

1 ~~Facilities~~ Residential Assisted Living Association."

3 SECTION 2. All provisions of this act of a general and permanent nature
4 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
5 Revision Commission shall incorporate the same in the Code.

7 SECTION 3. If any provision of this act or the application thereof to
8 any person or circumstance is held invalid, such invalidity shall not affect
9 other provisions or applications of the act which can be given effect without
10 the invalid provision or application, and to this end the provisions of this
11 act are declared to be severable.

13 SECTION 4. All laws and parts of laws in conflict with this act are
14 hereby repealed.
