21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code 25-29-101(c) pertaining to the Arkansas Deaf  
24 and Hearing Impaired Telecommunications Services Corporation is amended to  
25 read as follows:

26 (c) ~~The Joint Committee on Advanced Communications and Information~~  
27 ~~Technology shall provide the Governor with a list of two (2) names for each~~  
28 ~~position and the Governor shall make appointments from the recommendations of~~  
29 ~~the committee no later than June 1, 1997. The Governor shall choose one (1)~~  
30 ~~name from a list of three (3) names submitted by representatives of the deaf~~  
31 ~~and hearing impaired community and one (1) name from a list of three (3) names~~  
32 ~~submitted by representatives of Arkansas local exchange carriers.~~

34 SECTION 2. All provisions of this act of a general and permanent nature  
35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
36 Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
