16 "URGING THE DEPARTMENT OF FINANCE AND  
17 ADMINISTRATION TO NAME THE DFA BUILDING  
18 AT 1509 WEST 7TH STREET THE SMITH-STORY-  
19 HOGAN BUILDING IN HONOR AND MEMORY OF  
20 *HONORABLE WILLIAM J. SMITH*, MR. FRANK  
21 STORY, AND MR. JULIAN HOGAN. "

26 *WHEREAS, the Honorable William J. Smith is a distinguished Arkansas*  
27 *lawyer and jurist, was legal advisor to several Arkansas governors, and served*  
28 *as an Associate Justice of the Arkansas Supreme Court; the late Mr. Frank*  
29 *Story was Secretary of the State Board of Finance for many years; and the late*  
30 *Mr. Julian Hogan was Director of the Office of Budget and Preaudit of the*  
31 *State Comptroller's Office and one of the leading fiscal authorities in state*  
32 *government for many years; and*

33 *WHEREAS, Judge Smith, Mr. Story, and Mr. Hogan were the architects of*  
34 *the Arkansas Revenue Stabilization Law which was enacted in 1945 during the*  
35 *administration of Governor Ben Laney; and*

36 *WHEREAS, the Revenue Stabilization Law is a unique financial tool*

1 designed to assure that state spending is consistent with state revenue  
2 collections, and it has in the past and continues to successfully accomplish  
3 that admirable purpose; and

4 WHEREAS, it is most appropriate that the Department of Finance and  
5 Administration Building at 1509 West Seventh Street be named the Smith-Story-  
6 Hogan Building, in honor of *the Honorable William J. Smith, and in memory of*  
7 Mr. Frank Story, and Mr. Julian Hogan,

9 NOW THEREFORE,

10 BE IT RESOLVED BY THE SENATE OF THE EIGHTY-SECOND GENERAL ASSEMBLY OF THE  
11 STATE OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

13 The General Assembly hereby urges the Department of Finance and  
14 Administration to name the Department of Finance and Administration Building  
15 at 1509 West Seventh Street the Smith-Story-Hogan Building, and to cause  
16 appropriate signs to be installed on the building to display that name.

18 BE IT FURTHER RESOLVED that upon adoption of this Resolution, the  
19 Secretary of the Senate shall transmit a copy hereof to the Director of the  
20 Department of Finance and Administration.
