11 RELATING TO USED MOTOR VEHICLE DEALER LICENSING
12 REQUIREMENT MANDATING THE COMPLETION OF A THREE-HOUR
13 EDUCATIONAL SEMINAR APPROVED BY THE DEPARTMENT OF
14 ARKANSAS STATE POLICE DURING THE TWELVE-MONTH PERIOD
15 IMMEDIATELY PRECEDING THE DATE OF THE APPLICATION.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. Arkansas Code 23-112-607(d) is repealed:

27 ~~(d)(1) Effective November 15, 1999, every application for the issuance~~
28 ~~or renewal of a used motor vehicle dealer's license shall be accompanied by or~~
29 ~~supported by such evidence as the department shall prescribe, documenting the~~
30 ~~completion of a three-hour educational seminar approved by the department,~~
31 ~~during the twelve-month period immediately preceding the date of the~~
32 ~~application.~~

33 ~~(2) The educational seminar shall include but is not limited to:~~

34 ~~(A) The dealer requirements of this subchapter;~~

35 ~~(B) The rules and general provisions promulgated to~~
36 ~~implement, enforce, and administer this subchapter;~~

1 ~~(C) The requirements of the Office of Motor Vehicle of the~~
2 ~~Revenue Division of the Department of Finance and Administration; and~~

3 ~~(D) Such other information that will promote good business~~

6 ~~(3) Each educational seminar must be sponsored by a nonprofit~~
7 ~~corporation authorized to conduct business in Arkansas that develops and~~
8 ~~presents educational programs which enhance the knowledge and competence of~~
9 ~~used motor vehicle dealers, their sales persons, and service personnel for the~~
10 ~~benefit of the public.~~
