19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 23-112-607(d) is repealed.

22 ~~(d)(1) Effective November 15, 1999, every application for the issuance~~  
23 ~~or renewal of a used motor vehicle dealer's license shall be accompanied by or~~  
24 ~~supported by such evidence as the department shall prescribe, documenting the~~  
25 ~~completion of a three-hour educational seminar approved by the department,~~  
26 ~~during the twelve-month period immediately preceding the date of the~~  
27 ~~application.~~

28 ~~(2) The educational seminar shall include but is not limited to:~~  
29 ~~(A) The dealer requirements of this subchapter;~~  
30 ~~(B) The rules and general provisions promulgated to~~  
31 ~~implement, enforce, and administer this subchapter;~~  
32 ~~(C) The requirements of the Office of Motor Vehicle of the~~  
33 ~~Revenue Division of the Department of Finance and Administration; and~~  
34 ~~(D) Such other information that will promote good business~~  
35 ~~practices. The educational seminar requirement shall not include written or~~  
36 ~~oral exams.~~

1           ~~(3) Each educational seminar must be sponsored by a nonprofit~~  
2 ~~corporation authorized to conduct business in Arkansas that develops and~~  
3 ~~presents educational programs which enhance the knowledge and competence of~~  
4 ~~used motor vehicle dealers, their sales persons, and service personnel for the~~  
5 ~~benefit of the public.~~

6           ~~(4) The department shall promulgate rules to implement this~~
