## For An Act To Be Entitled

9 AN ACT TO ESTABLISH A FREE PERMANENT SPECIAL MOTOR  
10 VEHICLE LICENSE PLATE FOR THE SPOUSE OF A LAW  
11 ENFORCEMENT OFFICER WHO WAS KILLED IN THE LINE OF  
12 DUTY; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT TO ESTABLISH A FREE PERMANENT  
15 SPECIAL MOTOR VEHICLE LICENSE PLATE FOR  
16 THE SPOUSE OF A LAW ENFORCEMENT OFFICER  
17 WHO WAS KILLED IN THE LINE OF DUTY.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code Title 27, Chapter 15 is amended to add an additional  
24 subchapter to read as follows:

25 Subchapter 35. Killed In The Line of Duty Special Plates.

26 27-15-3501. In general.

27 (a) The Director of the Department of Finance and Administration shall  
28 provide for and issue a special "Killed In The Line Of Duty" motor vehicle  
29 license plate.

30 (b) The license plates shall be issued in the manner and subject to the  
31 conditions prescribed in this subchapter.  
32

33 27-15-3502. Design.

34 (a) On the left side of the special license plate there shall be the  
35 image of a badge in a design approved by the Director of the Department of  
36 Arkansas State Police.

1        (b)(1) On the right side of the special license plate the badge number  
2 of the law enforcement officer who was killed in the line of duty shall be  
3 displayed.

4        (2) The Department of Finance and Administration may add  
5 additional lettering or numbering if the same badge number would appear more  
6 than once.

7        (c) In lieu of the legend "The Natural State" or any succeeding legend,  
8 the special license plates shall have placed across the bottom thereof the  
9 words "Killed In The Line Of Duty."

11        27-15-3503. Eligibility.

12        The owner of a motor vehicle who is a resident of this state and who was  
13 the surviving spouse of an Arkansas law enforcement officer killed in the line  
14 of duty is entitled to register one (1) automobile, as defined by § 27-14-  
15 601(a)(1), or one (1) Class One truck, as defined by § 27-14-601(a)(3)(A), and  
16 receive a free special permanent license plate under this subchapter.

17  
18        27-15-3504. Transfer to another vehicle.

19        Special license plates issued under this subchapter may be transferred  
20 from one vehicle to another pursuant to § 27-14-914.

21  
22        27-15-3505. Rules and regulations.

23        The Director of the Department of Finance and Administration shall  
24 promulgate such reasonable rules and regulations and prescribe such forms as  
25 the director determines to be necessary for effectively and efficiently  
26 carrying out the intent and purposes of this subchapter.
