3	(a) Upon payment of the fee required by law for registration of the		
4	vehicle, payment of an additional ten dollar (\$10.00) handling and		
5	administrative fee for the issuance of a special license plate, and		
6	presentation and proof of eligibility for a special license plate, the		
7	Department of Finance and Administration shall issue the appropriate special		
8	license plate to the vehicle owner.		
9	(b)(1) The handling and administrative fee of ten dollars (\$10.00)
