- 2 (a) There is created the <u>Arkansas Rita Rowell Hale</u> Prenatal and Early 3 Childhood Nurse Home Visitation Program Advisory Council.
- 4 (b) The council shall consist of eleven (11) members to be appointed by 5 the Governor as follows:
- 6 (1) Two (2) members from the Department of Health, to be 7 nominated by the Director of the Department of Health;
- 8 (2) Two (2) members from the College of Medicine of the 9 University of Arkansas for Medical Sciences, to be nominated by the Dean of 10 the College of Medicine;
- 11 (3) One (1) member from the College of Nursing of the University 12 of Arkansas for Medical Sciences, to be nominated by the Dean of the College 13 of Nursing;
 - (4) One (1) member from the Arkansas Nurses Association;
- 15 (5) One (1) member from the University of Arkansas at Little Rock 16 School of Social Work, to be nominated by the Director of the School of Social 17 Work:
- 18 (6) One (1) member from the Division of Early Childhood 19 Development of the Department of Human Services;
- 20 (7) One (1) member from the State Child Abuse and Neglect 21 Prevention Board, to be nominated by the director; and
- 22 (8) Two (2) members from the public at large, at least one (1) of 23 whom shall be active in child advocacy within the state, and one (1) of whom 24 shall be an African American.
- 25 (c) The Director of the Arkansas Rita Rowell Hale Prenatal and Early
 26 Childhood Nurse Home Visitation Program shall serve as an ex officio member of
 27 the Board.

29 SECTION 3. Arkansas Code 20-78-708 is amended to read as follows: 30 20-78-708. Funding.

The Director of the Department of Health is authorized to utilize available general revenue savings and allowable federal funds in support of the activities described in this subchapter in the event that sufficient funds are not allocated for the <u>Rita Rowell Hale</u> Prenatal and Early Childhood Nurse Home Visitation Program herein. The director is authorized to transfer appropriations and funds, as necessary, only for the purposes provided for in

HB1130

this subchapter. Upon approval of the Chief Fiscal Officer of the State and review by the Legislative Council, such transfers shall be made upon the books of the Department of Finance and Administration, the Auditor of State and the Treasurer of State.
