

33	(a) The special Former Legislator license plates shall be designed by

4	27-15-3503. Issuance to former legislators.		
5	(a) The Department of Finance and Administration shall issue a vehicle		
6	owner a Former Legislator license plate for a vehicle upon:		
7	(1) payment of the fee required by law for registration of the		
8	vehi cl e;		
9	(2) payment of an additional ten dollars (\$10.00) handling and		
10	administrative fee for the issuance of a special Former Legislator license		
11	plate; and		
12	(3) presentation of proof of being a former member of the		
13	<u>Arkansas General Assembly.</u>		
14	(b)(1) The handling and administrative fee of ten dollars (\$10.00)		
15	shall be deposited to the State Central Services Fund for the benefit of the		
16	Revenue Division and shall be credited to the Revenue Division as supplemental		
17	and in addition to all other funds as may be deposited for the benefit of the		
18	Revenue Division.		
19	(2) The handling and administrative fee shall not be considered or		
20	credited to the Revenue Division as "direct revenues".

22	<u>27-15-3504. Renewal.</u>		
23	Special Former Legislator license plates issued under this subchapter		
24	may be renewed annually at the regular fee. Registration may continue from		
25	year to year as long as it is renewed each year within the time and manner		
26	required by law.

28	27-15-3505. Transferring plate.		
29	Former Legislator license plates issued under this subchapter may be		
30	transferred from one vehicle to another pursuant to § 27-14-914.
