## A Bill

HOUSE BILL 1380

### For An Act To Be Entitled

AN ACT TO PERMIT THE OFFICE OF DRIVER SERVICES TO  
SUSPEND THE DRIVING PRIVILEGES OF A PERSON USING THE  
DRIVER'S LICENSE OR IDENTIFICATION CARD OF ANOTHER  
PERSON, OR FOR USING A FRAUDULENT DRIVER'S LICENSE OR  
IDENTIFICATION CARD; AND FOR OTHER PURPOSES.

### Subtitle

TO PERMIT THE OFFICE OF DRIVER SERVICES  
TO SUSPEND THE DRIVER'S LICENSE OF A  
PERSON USING A FALSE DRIVER'S LICENSE OR  
IDENTIFICATION CARD.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code 27-16-907(a) is amended to read as follows:

(a) The Office of Driver Services is authorized to suspend the license  
of any driver ~~without a preliminary~~ after a hearing upon a showing by its  
records or other sufficient evidence that the licensee:

(1) Has been convicted of an offense for which mandatory  
revocation of the license is required;

(2) Has been involved as a driver in any accident resulting in  
the death or personal injury of another or in serious property damage;

(3) Is an habitually reckless or negligent driver of a motor  
vehicle;

(4) Is an habitual violator of the traffic laws;

(5) Is incompetent to drive a motor vehicle;

(6) Has permitted an unlawful or fraudulent use of his license;

1 (7) Has committed an offense in another state which if committed  
2 in this state would be grounds for suspension or revocation; ~~or~~

3 (8) Is receiving any type of welfare, tax, or other benefit or  
4 exemption as a blind or nearly blind person if the correctable vision of the  
5 person is less than 20/50 in the better eye or if the total visual field of  
6 the person is less than one hundred five degrees (105°); ~~or~~

7 (9) Any person who is not lawfully within the United States; ~~or~~

8 (10) Was found by the office or its agent to have used or  
9 attempted to use a driver's license or identification card issued under §27-  
10 16-805, that was fraudulent, counterfeit or altered; or

11 (11) Was found by the office or its agent to have used or  
12 attempted to use the driver's license or identification card of another person  
13 by representing it as his or her own license or identification card issued  
14 under § 27-16-805.
