Arkansas Code 27-16-907(a) is amended to read as follows: 24 25 (a) The Office of Driver Services is authorized to suspend the license 26 of any driver without a preliminary after a hearing upon a showing by its 27 records or other sufficient evidence that the licensee: (1) Has been convicted of an offense for which mandatory 28 29 revocation of the license is required; (2) Has been involved as a driver in any accident resulting in 30 31 the death or personal injury of another or in serious property damage; 32 (3) Is an habitually reckless or negligent driver of a motor 33 vehi cle; (4) Is an habitual violator of the traffic laws; 34 35 (5) Is incompetent to drive a motor vehicle; 36 (6) Has permitted an unlawful or fraudulent use of his license;
