3	SECTION 3. (a) The Arkansas Delta Development Commission shall consist
4	of eleven (11) members, each of whom shall be a resident of the Delta region.
5	(b)(1) Two (2) members shall be appointed by the Speaker of the House;
6	(2) Two (2) members shall be appointed by the President Pro
7	Tempore of the Senate.
8	(3) Six (6) members shall be appointed by the Governor and one (1)
9	of the six (6) shall be a co-chairman of the committee.
10	(4) One (1) member shall be appointed jointly by the Speaker of
11	the House and the President Pro Tempore of the Senate and shall be a co-
12	chairman of the committee.
13	(c)(1) The co-chairs shall each serve one (1) year terms.
14	(2) The remaining nine (9) members shall serve three (3) year
15	staggered terms, to be determined by lot at the first meeting of the
16	commission so that three (3) serve one-year terms, three (3) serve two-year
17	terms, and three (3) serve three-year terms.
18	(d)(1) The co-chair appointed by the Governor may be removed for cause

33	SECTION 4. <u>(a) The commission shall meet quarterly, and at other such</u>
34	times as the co-chairs acting jointly shall designate.
35	(b) At least twice annually, the commission shall meet in a place or
36	places within the Delta region which the commission shall deem appropriate.

1	(c) The first meeting of the commission shall be called by the co-
2	chairs within thirty (30) days after the effective date of this act.
3	(d) A quorum shall consist of not fewer than six (6) members present at
4	any regular or special meeting, and a majority affirmative vote of members
5	attending shall be necessary for the disposition of any business.

7	SECTION 5. (a) The commission may employ an executive director and fix
8	his or her compensation, duties, authority, and responsibilities.
9	(b) The director may hire support staff and other personnel as

12	the commission and shall be, ex officio, the disbursing agent of all funds

15	SECTION 6. (a) The commission shall:
16	(1) Develop a comprehensive economic profile of each county in

18	(2) Develop, in cooperation with state, county and local
19	governments, a coordinated plan to identify those Delta region counties most
20	in need of economic assistance;
21	(3) Develop priority rankings to ensure that greater resources
22	are directed to the most distressed Delta region counties, while ensuring that
23	all Delta region counties receive some assistance;
24	(4)(A) Provide assistance to Delta region counties to help them
25	meet their cost share responsibilities to other state programs; and
26	(B) Provide cost share assistance on the basis of each
27	county's priority ranking; and
28	(5) Monitor county priority rankings to ensure that rankings are
29	revised when necessary or appropriate.
30	(b) The commission shall adopt, and may modify, rules for the conduct
31	of its business and shall keep a public record of its transactions, findings,
32	and determinations.

7	programs operating in or for the Delta region to fund research, technical
8	assistance and any construction of facilities necessary for any such programs.
9	(f)(1) The commission may receive gifts, grants, donations, fee
10	conveyances, or transfers of money and property, both real and personal, from
11	private and public sources, or federal, or either; and to sell or dispose of
12	such property, real and personal, or either, as the commission deems
13	advi sabl e.
14	(2) Any funds and income from any property so furnished shall be
15	placed in the State Treasury in the Arkansas Delta Region Trust Fund and shall
16	be expended in the same manner as other state moneys are expended, upon
17	vouchers drawn by the director of the commission.
8	(g) The commission shall prepare and publicize through the various
19	appropriate media, including paid advertisements in instances where

4	SECTION 9. (a) There is established on the books of the Treasurer of
5	State, Auditor of State, and Chief Fiscal Officer of the State a fund to be
6	known as the Arkansas Delta Region Trust Fund.
7	(b) The fund shall consist of funds received by the commission and any
8	other moneys as may be provided by the General Assembly, there to be used for
9	the administration and operations of the commission.

11	SECTION 10. Arkansas Code 25-16-905 is amended to read as follows:
12	25-16-905. Stipend - Authorization for \$100.
13	Each of the following state boards may, by a majority vote of the total
14	membership of the board cast during its first regularly scheduled meeting of
15	each calendar year, authorize payment to its members of a stipend not to
16	exceed one hundred dollars (\$100) per meeting, examination, evaluation, or
17	inspections attended or for any day while performing any proper business of
18	the board, and the board members shall receive no other compensation, expense
19	reimbursement, or in-lieu-of payments except as provided in § 25-16-902:
