## For An Act To Be Entitled

10 AN ACT TO INCREASE THE FEE FOR THE ISSUANCE OR  
11 RENEWAL OF DRIVER LICENSES FOR THE BENEFIT OF THE  
12 ARKANSAS STATE POLICE, AND FOR OTHER PURPOSES.

### Subtitle

15 AN ACT TO INCREASE THE FEE FOR THE  
16 ISSUANCE OR RENEWAL OF DRIVER LICENSES  
17 FOR THE BENEFIT OF THE ARKANSAS STATE  
18 POLICE.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code 27-16-801, pertaining to driver license fees,  
25 is amended to add an additional subsection to read as follows:

26 (i) In addition to the license fees imposed in  
27 subsections (a) and (e) of this section, a fee of six dollars (\$6.00) shall be  
28 charged for the issuance or renewal of any Class D, M, or MD license. The fees  
29 collected under this subsection shall be remitted to the State Treasury, there  
30 to be deposited as special revenues to the credit of the Department of  
31 Arkansas State Police Fund, to be used for the payment of health insurance  
32 premiums for uniformed employees of the Arkansas State Police.  
33

34 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the General  
35 Assembly that the State Police Insurance System is under-funded; that the  
36 failure of this act to provide immediate additional revenue for the system

1 will disrupt the proper administration of the State Police Insurance System,  
2 and such a disruption could work irreparable harm upon the proper  
3 administration and coverage of essential insurance protection provided to  
4 officers of the Department of Arkansas State Police. Therefore, an emergency  
5 is declared to exist and this act being immediately necessary for the  
6 preservation of the public peace, health and safety shall become effective on  
7 May 1, 2001.
