For An Act To Be Entitled

10 AN ACT TO AMEND ARKANSAS CODE TITLE 27, CHAPTER 15, TO
11 ADD A SUBCHAPTER 35 TO ESTABLISH A SPECIAL LICENSE
12 PLATE FOR PERSONS AWARDED THE DISTINGUISHED FLYING
13 CROSS AND TO PRESCRIBE REGISTRATION FEES FOR THE
14 LICENSE PLATES; AND FOR OTHER PURPOSES.

16 TO ESTABLISH A SPECIAL LICENSE PLATE FOR
17 PERSONS AWARDED THE DISTINGUISHED FLYING
18 CROSS AND TO PRESCRIBE REGISTRATION

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code Title 27, Chapter 15, is amended to add an
26 additional subchapter to read as follows:

27 Subchapter 35 - Distinguished Flying Cross

28 27-15-3501. Distinguished Flying Cross License plate authorized.

29 (a) Military medals are adornments given as personal awards for
30 outstanding service, bravery, or a specific achievement. The U. S. Air Force
31 awards the Distinguished Flying Cross to those who exhibit extraordinary
32 heroism or achievement in aerial flight. This subchapter recognizes those
33 persons for this personal achievement.

34 (b) The Director of the Department of Finance and Administration shall
35 provide for and issue special license plates to persons awarded the
36 Distinguished Flying Cross in the manner and subject to the conditions

1 prescribed in this subchapter.

2
3 27-15-3502. Design of plate and rules and regulations.

4 (a) The special Distinguished Flying Cross license plates shall be of
5 standard color and design as is currently issued by the Department of Finance
6 and Administration, except that, in lieu of the legend "The Natural State" or
7 any succeeding legend, the license plates shall have placed across the bottom
8 thereof a permanent decal bearing the words "Distinguished Flying Cross". *The*
9 *recipient of a Distinguished Flying Cross special license plate may insert a*
10 *decal in the center of the license plate depicting the Distinguished Flying*
11 *Cross medal, provided such decal does not impede the ability to read the*
12 *license plate number.*

13 (b) The director of the department shall promulgate reasonable rules
14 and regulations and prescribe any forms as the director determines to be
15 necessary for effectively and efficiently carrying out the intent and purposes
16 of this subchapter.

17
18 27-15-3503. Issuance to persons awarded the Distinguished Flying Cross.

19 (a) Upon payment of the fee required by law for registration of the
20 vehicle, payment of an additional ten dollar (\$10.00) handling and
21 administrative fee for the issuance of a special Distinguished Flying Cross
22 license plate, and presentation of proof of being awarded the Distinguished
23 Flying Cross, the Department of Finance and Administration shall issue the
24 appropriate special license plate to the vehicle owner.

25 (b)(1) The handling and administrative fee of ten dollars (\$10.00)
26 shall be deposited in the State Central Services Fund for the benefit of the
27 Revenue Division and shall be credited to the Revenue Division as supplemental
28 and in addition to all other funds as may be deposited for the benefit of the
29 Revenue Division.

30 (2) The handling and administrative fee shall not be considered
31 or credited to the Revenue Division as "direct revenues".

32
33 27-15-3504. Renewal.

34 Special Distinguished Flying Cross license plates issued under this
35 subchapter may be renewed annually at the regular fee. Registration may
36 continue from year to year as long as it is renewed each year within the time

1 and manner required by law.

2

3 27-15-3505. Transferring plate.

4 Distinguished Flying Cross license plates issued under this subchapter

5 may be transferred from one vehicle to another pursuant to § 27-14-914.
