23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. REGULAR SALARIES. There is hereby established for the Division
26 of Legislative Audit of the Legislative Joint Auditing Committee for the 2001-
27 2003 biennium, the following maximum number of regular employees whose
28 salaries shall be governed by the provisions of the Uniform Classification and
29 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
30 laws amendatory thereto. Provided, however, that any position to which a
31 specific maximum annual salary is set out herein in dollars, shall be exempt
32 from the provisions of said Uniform Classification and Compensation Act. All
33 persons occupying positions authorized herein are hereby governed by the
34 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
35 Code §21-5-101), or its successor.

 5 Auditing Committee for the biennial period ending June 30, 2003, the

 20 SECTION 3. APPROPRIATION - CAFR AUDIT. There is hereby appropriated, to the
 21 Division of Legislative Audit of the Legislative Joint Auditing Committee, to
 22 be payable from the State General Services Fund Account, for expenses related
 23 to securing the services of an independent auditor to audit the State of
 24 Arkansas' Comprehensive Annual Financial Report (CAFR) by the Division of
 25 Legislative Audit of the Legislative Joint Auditing Committee for the biennial
 26 period ending June 30, 2003, the following:

 34 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 35 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. Of the funds
 36 appropriated for Professional Fees and Services, \$150,000 is restricted in

1 each of the two fiscal years for securing ~~audits of municipalities and/or~~
2 ~~local school districts.~~ professional services, in areas of expertise other
3 than audit, for any special needs or requirements associated with any program
4 evaluations and/or special reports. Any unexpended balance of appropriations
5 which remains at the close of the fiscal year ending June 30, ~~2000~~ 2002 shall
6 be transferred forward and made available for the year ending June 30, ~~2001~~
7 2003. Services contracted pursuant to this provision shall only be secured
8 upon approval of the Executive Committee of the Legislative Joint Auditing
9 Committee.

10 The provisions of this section shall be in effect only from July 1, 2001
11 through June 30, 2003.

12
13 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
14 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
15 PROVISION. Any unexpended balance of the appropriations of ~~Extra Help,~~
16 ~~Personal Services Matching,~~ or Maintenance and General Operations in Section ~~3~~
17 2 of this Act which remains at the close of the fiscal year ending June 30,
18 ~~2000~~ 2002 shall be transferred forward and made available for the same purpose
19 for the fiscal year ending June 30, ~~2001~~ 2003.

20 The provisions of this section shall be in effect only from July 1, 2001
21 through June 30, 2003.

22
23 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
24 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 2004 SOUTHERN
25 LEGISLATIVE CONFERENCE HOST COMMITTEE. The President Pro Tempore of the
26 Arkansas Senate and the Speaker of the Arkansas House of Representatives are
27 hereby authorized to designate an appropriate Host Committee consisting of
28 members of the Arkansas General Assembly to conduct advanced planning and to
29 conduct a program of activities for attendees of the 2004 Annual Meeting of
30 the Southern Legislative Conference of the Council of State Governments to be
31 held in Arkansas. Upon authorization of the President Pro Tempore and the
32 Speaker of the House, the Legislative Auditor shall have a voucher prepared
33 and cause a warrant to be issued in the amount as appropriated in this Act for
34 expenses of planning and hosting the Southern Legislative Conference. The
35 Legislative Auditor shall deposit or invest the funds in an account or
36 accounts in a qualified financial institution or institutions located in the

1 State of Arkansas established solely for planning and hosting the Southern
 2 Legislative Conference. The Host Committee shall have oversight
 3 responsibilities over the funds. The Legislative Auditor shall be custodian
 4 of these funds, which shall be considered state governmental trust funds.
 5 These funds are exempt from the provisions of the General Accounting and
 6 Budgetary Procedures Law. Any funds remaining in the account after all
 7 expenses for hosting the Southern Legislative Conference have been paid, not
 8 exceeding the amount appropriated for hosting the Southern Legislative
 9 Conference, shall be deposited in the State Treasury to the credit of the
 10 State Central Services Fund.

11
 12 SECTION 7. APPROPRIATION. There is hereby appropriated, to the Division of
 13 Legislative Audit of the Legislative Joint Auditing Committee, to be payable
 14 from the State Central Services Fund, to assist in defraying the expenses of
 15 hosting the Southern Legislative Conference, the sum of\$100,000.

16
 17 SECTION 8. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
 18 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
 19 appropriations as provided in this Act, the agency disbursing officer shall
 20 monitor the level of fund balances in relation to expenditures on a monthly
 21 basis. If any proposed expenditures would cause a fund balance to decline to
 22 less than fifty percent (50%) of the balance available on July 1, 2001, the
 23 disbursing officer shall immediately notify the executive head of the agency.
 24 Prior to any obligations being made under these circumstances, the agency head
 25 shall file written documentation with the Chief Fiscal Officer of the State
 26 requesting approval of the expenditures. Such documentation shall provide
 27 sufficient financial data to justify the expenditures and shall include the
 28 following:

- 29 1) a plan that clearly indicates the specific fiscal impact of such
 30 expenditures on the fund balance.
- 31 2) information clearly indicating and explaining what programs would be cut or
 32 any other measures to be taken by the agency to restore the fund balance.
- 33 3) the extent to which any of the planned expenditures are for one-time costs
 34 or one-time purchase of capitalized items.
- 35 4) a statement certifying that the expenditure of fund balances will not
 36 jeopardize the financial health of the agency, nor result in a permanent

1 depletion of the fund balance.

2 (B) The Chief Fiscal Officer of the State shall review the request and
3 approve or disapprove all or any part of the request , after having sought
4 prior review by the Legislative Council.

5

6 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
7 this act shall be limited to the appropriation for such agency and funds made
8 available by law for the support of such appropriations; and the restrictions
9 of the State Purchasing Law, the General Accounting and Budgetary Procedures
10 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
11 Restrictions Act, or their successors, and other fiscal control laws of this
12 State, where applicable, and regulations promulgated by the Department of
13 Finance and Administration, as authorized by law, shall be strictly complied
14 with in disbursement of said funds.

15

16 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly
17 that any funds disbursed under the authority of the appropriations contained
18 in this act shall be in compliance with the stated reasons for which this act
19 was adopted, as evidenced by the Agency Requests, Executive Recommendations
20 and Legislative Recommendations contained in the budget manuals prepared by
21 the Department of Finance and Administration, letters, or summarized oral
22 testimony in the official minutes of the Arkansas Legislative Council or Joint
23 Budget Committee which relate to its passage and adoption.

25 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General
26 Assembly, that the Constitution of the State of Arkansas prohibits the
27 appropriation of funds for more than a two (2) year period; that the
28 effectiveness of this Act on July 1, 2001 is essential to the operation of the
29 agency for which the appropriations in this Act are provided, and that in the
30 event of an extension of the Regular Session, the delay in the effective date
31 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
32 administration and provision of essential governmental programs. Therefore, an
33 emergency is hereby declared to exist and this Act being necessary for the
34 immediate preservation of the public peace, health and safety shall be in full
35 force and effect from and after July 1, 2001.
