4	(2) It is the intent of the General Assembly that amounts claimed and
5	disbursed under the provisions of this subsection be for actual expenses
6	incurred and documented and not as a form of salary supplement.
7	
8	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the General
9	Assembly that the Constitution of the State of Arkansas prohibits the
10	appropriation of funds for more than a two (2) year period; that the
11	effectiveness of this Act on July 1, 2001 is essential to the operation of the
12	agency in providing reimbursement allowance and expenses of ABC Enforcement
13	officers, and that in the event of an extension of the Regular Session, the
14	delay in the effective date of this Act beyond July 1, 2001 could work
15	irreparable harm upon the proper administration and provision of essential
16	governmental programs. Therefore, an emergency is declared to exist and this
17	act being immediately necessary for the preservation of the public peace,
18	health and safety shall become effective on July 1, 2001.
