Arkansas Code 6-51-301(b), pertaining to proposed new 24 25 vocational centers, is amended to read as follows: 26 (b) Such a request for a proposed new center must provide the necessary information and assurances according to the guidelines for approval of new 27 centers established by the State Board of Vocational Education State Board of 28 29 Workforce Education and Career Opportunities. 30 31 SECTION 2. Arkansas Code 6-51-302, pertaining to approval of vocational centers establishments, is amended to read as follows: 32 6-51-302. 33 Approval of center establishment. (a) The State Board of Workforce Education and Career Opportunities may 34 35 approve the establishment of vocational centers to serve high school students 36 from several school districts in locations where services are needed to:

1 (1) Support economic, industrial, and employment development 2 efforts: 3 (2) Provide equity and substantially equal access to quality vocational programs; and 4 5 (3) Improve school programs to assist schools in meeting 6 accreditation standards. 7 (b) A comprehensive high school, a postsecondary technical institute or vocational technical school, a community or two year college, or a school 8 9 established by an education service cooperative which shall plan to offer five (5) or more occupation-specific vocational technical programs may be approved 10 11 as a center by the board. 12 (c)(b) The board shall only approve centers which utilize existing 13 vocational education resources such as facilities, equipment, etc., except in 14 those geographic areas in which comprehensive vocational offerings have not 15 been developed and the state board determines that those resources must be 16 developed to accomplish the above purposes. 17 (c) If a postsecondary vocational-technical school or two-year college, 18 which operates a secondary vocational center, merges or consolidates with a public institution of higher education, the secondary vocational center may 19 20 continue to be administered by the institution of higher education involved in 21 the merger or consolidation. 22 23 SECTION 3. Arkansas Code 6-51-303 is amended to read as follows: 6-51-303. Administration. 24 25 (a) The management, maintenance, and operation of a center shall be the 26 responsibility of the local school or institution approved by the State Board 27 of Vocational Education State Board of Workforce Education and Career 28 Opportunities to be the center. 29 (b) A center shall be administered in accordance with the guidelines and policies established by the State Board of Vocational Education State 30 31 Board of Workforce Education and Career Opportunities. 32 33 SECTION 4. Arkansas Code 6-51-305(b)(2), pertaining to financing

(2) Any funds received by an institution or school district operating a vocational center either from tuition or from state funds unexpended at the

vocational centers, is amended to read as follows:

1	end of the school year shall be carried forward for the sole purpose of
2	conducting summer programs and community-based education centers or supporting
3	vocational center operations in succeeding years.
4	
5	SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
6	Assembly that that it is necessary for the welfare of the students enrolled in
7	vocational centers to have uninterrupted financial support from the state and
8	that institutional school districts need to carry forward funds from the 2000-
9	2001 fiscal year for the purposes of operating vocational centers. Therefore,
10	an emergency is declared to exist and this act being immediately necessary for
11	the preservation of the public peace, health and safety shall become effective
12	on the date of its approval by the Governor. If the bill is neither approved
13	nor vetoed by the Governor, it shall become effective on the expiration of the
14	period of time during which the Governor may veto the bill. If the bill is
15	vetoed by the Governor and the veto is overridden, it shall become effective
16	on the date the last house overrides the veto.
