 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Any unexpended balance of the appropriation authorized in Item (09) of Section 3 of this Act which remains at the close of the fiscal year ending June 30, 2000 2002, shall be carried forward and made available for the same purpose for the fiscal year ending June 30, 2001 2003.

The provisions of this section shall be in effect only from July 1, 2001 through June 30, 2003.

SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Any unexpended balance of the appropriation authorized for Building Repairs/Maintenance in Item (06) of Section 3 of this Act which remains at the close of the fiscal year ending June 30, 2000 2002, shall be carried forward and made available for the same purpose for the fiscal year ending June 30,

1 2001 2003. 2 The provisions of this section shall be in effect only from July 1, 2001 3 through June 30, 2003. 4 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 7 CONTINGENCY RESTRICTION. TAX DIVISION. In the event additional 8 appropriations become necessary that are not authorized or contemplated in 9 Section 8 of this Act and specific cases, situations, and/or programs make it necessary that the Arkansas Public Service Commission - Tax Division receives 10 11 additional appropriations to carry out the objectives of the Division, the Chairman of the Arkansas Public Service Commission is hereby authorized to 12 13 request the approval of the Governor and the Chief Fiscal Officer of the State for transfers of the appropriations provided in the Contingency line item of 14 15 Section 8 of this Act to other line items within Section 8. In no event shall 16 the transfers in any fiscal year exceed the appropriations provided in the 17 Contingency line item of Section 8 of this Act. The Governor may approve or modify such request for transfer of appropriations as in his judgment he deems 18 19 necessary, and shall seek prior review of the Arkansas Legislative Council and inform the Chief Fiscal Officer of the State. Upon notification, the Chief 20 21 Fiscal Officer of the State shall direct the State Auditor to process said 22 transfer upon his books in accordance with the provisions as set out herein. 23 24 The provisions of this section shall be in effect only from July 1, 2001 25 through June 30, 2003. 26 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RURAL AND 29 COMMUNITY LIAISON. GENERAL JOB RESPONSIBILITIES. The Rural and Community 30 Liaison will serve as a two-way communication link between the Arkansas Public 31 Service Commission and utility customers in Arkansas, particularly those in 32 rural areas. The Rural and Community Liaison is responsible for providing 33 information to communities and rural utility customers concerning utility matters within the jurisdiction of the Commission. The Rural and Community 34 35 Liaison is also responsible for identifying questions and concerns that rural

utility customers may have concerning utility issues and relaying those

- 1 concerns to the Commissioners and the Commission Staff. In the performance of
- 2 <u>these duties, the Rural and Community Liaison will work with stakeholders in</u>
- 3 <u>rural areas and communities, including legislators, civic and community</u>

- 9 SECTION 16. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
- 10 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
- 11 appropriations as provided in this Act, the agency disbursing officer shall
- 12 monitor the level of fund balances in relation to expenditures on a monthly
- 13 basis. If any proposed expenditures would cause a fund balance to decline to
- 14 <u>less than fifty percent (50%) of the balance available on July 1, 2001, the</u>
- 15 disbursing officer shall immediately notify the executive head of the agency.
- 16 Prior to any obligations being made under these circumstances, the agency
- 17 <u>head shall file written documentation with the Chief Fiscal Officer of the</u>
