9 *AN ACT TO MAKE AN APPROPRIATION FOR CONSTRUCTING AND*
10 *EQUIPPING THE FIRE TRAINING FACILITY, PHASE II FOR THE*
11 *SAU-TECH FOR THE BIENNIAL PERIOD ENDING JUNE 30, 2003;*

15 AN ACT FOR THE SAU-TECH - FIRE TRAINING
16 ACADEMY-FIRE TRAINING FACILITY, PHASE II
17 APPROPRIATION FOR THE 2001-2003 BIENNIUM.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATIONS - FIRE TRAINING FACILITY, PHASE II. There is
23 hereby appropriated, to the SAU-Tech, to be payable from the General
24 Improvement Fund or its successor fund or fund accounts, the following:

25 (A) For constructing, equipping and associated costs of the Fire Training
26 Facility, Phase II, by the Fire Training Academy, the sum of\$500,000.
27

28 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
29 this act shall be limited to the appropriation for such agency and funds made
30 available by law for the support of such appropriations; and the restrictions
31 of the State Purchasing Law, the General Accounting and Budgetary Procedures
32 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
33 Restrictions Act, the Higher Education Expenditures Restrictions Act, or their
34 successors, and other fiscal control laws of this State, where applicable, and
35 regulations promulgated by the Department of Finance and Administration, as
36 authorized by law, shall be strictly complied with in disbursement of said

1 funds.

3 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
4 that any funds disbursed under the authority of the appropriations contained
5 in this act shall be in compliance with the stated reasons for which this act
6 was adopted, as evidenced by the Agency Requests, Executive Recommendations
7 and Legislative Recommendations contained in the budget manuals prepared by
8 the Department of Finance and Administration, letters, or summarized oral
9 testimony in the official minutes of the Arkansas Legislative Council or Joint
10 Budget Committee which relate to its passage and adoption.

12 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
13 Assembly, that the Constitution of the State of Arkansas prohibits the
14 appropriation of funds for more than a two (2) year period; that the
15 effectiveness of this Act on July 1, 2001 is essential to the operation of the
16 agency for which the appropriations in this Act are provided, and that in the
17 event of an extension of the Regular Session, the delay in the effective date
18 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
19 administration and provision of essential governmental programs. Therefore, an
20 emergency is hereby declared to exist and this Act being necessary for the
21 immediate preservation of the public peace, health and safety shall be in full
22 force and effect from and after July 1, 2001.
