he University of Arkansas are,	due to unforeseen circumstances, insufficient
or the University of Arkansas	to continue to provide essential governmental
ervices; that the provisions of	of this act will provide the necessary monies
or the University of Arkansas	to continue such services; and that a delay in
he effective date of this Act	could work irreparable harm upon the proper
ndministration and provision of	essential governmental programs. Therefore, ar
emergency is hereby declared to	exist and this Act being necessary for the

1	immediate preservation of the public peace, health and safety shall be in full
2	force and effect from and after the date of its passage and approval.
3	If the bill is neither approved nor vetoed by the Governor, it shall become
4	effective on the expiration of the period of time during which the Governor
5	may veto the bill. If the bill is vetoed by the Governor and the veto is
6	overridden, it shall become effective on the date the last house overrides the
7	veto.
