There is hereby appropriated, to the Department of Education, to be payable from the School Vehicle Insurance Reserve Trust Fund, for personal services and operating expenses of the Department of Education - School Motor Vehicle Self Insurance Program for the biennial period ending June 30, 2003, the following:

SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SCIENCE AND MATH EQUIPMENT. The funds appropriated in Item (07) of Section 3 of this Act, for the purpose of purchasing equipment or advanced technology for laboratory instruction and demonstration projects related to the teaching of science and mathematics shall be used to defray up to fifty percent (50%) of the total cost of the proposed equipment; provided, however, that the amount contributed by the Department of Education - General Education Division may not exceed \$5,000 per project.

The provisions of this section shall be in effect only from July 1, 2001

1	through June 30, 2003.

3	SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
4	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SCIENCE
5	AND MATH EQUIPMENT. The funds appropriated in Item (07) of Section 3 of this
6	Act shall be allocated in accordance with regulations and procedures
7	promulgated by the Department of Education - General Education Division with
8	priority given to those school districts demonstrating the greatest need.
9	
10	The provisions of this section shall be in effect only from July 1, 2001
11	through June 30, 2003.
12	
13	SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
14	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. Any
15	Federal Mineral Leasing Funds, Federal Forest Reserve Funds, Federal Flood
16	Control Funds, or any similar turnback funds in the State Treasury for which
17	the eligible county and/or school district cannot be identified may be
18	transferred to the Department of Education Public School Fund Account and used
19	for any lawful school purpose.

21	The provisions of this section shall be in effect only from July 1, 2001

24	SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

26	Notwithstanding any law pertaining to the transfer of year-end fund balances
27	or any law to the contrary, any funds which remain in the Department of
28	Education Fund Account at the end of a fiscal year shall remain in the
29	Department of Education Fund Account and made available to fund appropriation
30	authorized by law and made payable from the Department of Education Fund
31	Account for the following fiscal year.

33	The provisions of this section shall be in effect only from July 1, 2001

36	SECTION 22. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED

- 1 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
- 2 appropriations as provided in this Act, the agency disbursing officer shall
- 3 <u>monitor the level of fund balances in relation to expenditures on a monthly</u>
- 4 basis. If any proposed expenditures would cause a fund balance to decline to
- 5 less than fifty percent (50%) of the balance available on July 1, 2001, the
- 6 <u>disbursing officer shall immediately notify the executive head of the agency.</u>
- 7 Prior to any obligations being made under these circumstances, the agency
- 8 head shall file written documentation with the Chief Fiscal Officer of the
- 9 State requesting approval of the expenditures. Such documentation shall
- 10 provide sufficient financial data to justify the expenditures and shall
- 11 <u>include the following:</u>
- 12 1) a plan that clearly indicates the specific fiscal impact of such
- 13 expenditures on the fund balance.
- 14 <u>2) information clearly indicating and explaining what programs would be cut or</u>
- 15 <u>any other measures to be taken by the agency to restore the fund balance.</u>
- 16 3) the extent to which any of the planned expenditures are for one-time costs
- or one-time purchase of capitalized items.
- 18 4) a statement certifying that the expenditure of fund balances will not
- 19 <u>jeopardize the financial health of the agency, nor result in a permanent</u>
- 20 depletion of the fund balance.
- 21 (B) The Chief Fiscal Officer of the State shall review the request and
- 22 approve or disapprove all or any part of the request, after having sought
- 23 prior review by the Legislative Council.

- 25 SECTION 23. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
- 26 by this act shall be limited to the appropriation for such agency and funds
- 27 made available by law for the support of such appropriations; and the
- 28 restrictions of the State Purchasing Law, the General Accounting and Budgetary
- 29 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures

3	and Legislative Recommendations contained in the budget manuals prepared by

6	Budget Committee which relate to its passage and adoption.
7	
8	SECTION 25. EMERGENCY CLAUSE. It is found and determined by the General
9	Assembly, that the Constitution of the State of Arkansas prohibits the
10	appropriation of funds for more than a two (2) year period; that the
11	effectiveness of this Act on July 1, 2001 is essential to the operation of the
12	agency for which the appropriations in this Act are provided, and that in the
13	event of an extension of the Regular Session, the delay in the effective date
14	of this Act beyond July 1, 2001 could work irreparable harm upon the proper
15	administration and provision of essential governmental programs. Therefore, an
16	emergency is hereby declared to exist and this Act being necessary for the
17	immediate preservation of the public peace, health and safety shall be in full
18	force and effect from and after July 1, 2001.
